In accordance with Paragraph 22 of IOTC Resolution 12/05, please follow the below link for the list of large-scale tuna longline fishing vessels (LSTLVs) / Carrier vessels that were involved in possible infractions observed under the IOTC Regional Observer Programme for monitoring at sea transhipments, during 2012. You will also find in the same document, the responses that the Secretariat has received from some of the concerned fleets. As you will note some fleets have not yet provided their response for the cases observed.
