 Resolution 15/11 On the implementation of a limitation of fishing capacity of Contracting Parties and Cooperating Non-Contracting Parties.<sup>a</sup>

Indonesia has been implementing Resolution 15/11 through Ministerial Decree No. 107 year 2015 concerning National Tuna Management Plan,

Minister Regulation No. 30 year 2012 concerning Capture Fisheries that already amended lastly by Minister Regulation No. 26 year 2013

Minister Regulation No. 56 year 2014 concerning Moratorium on Fishing Permit

Minister Regulation No. 12 year 2012 concerning Capture Fisheries in High Seas.

There is a National Plan to limit fishing vessel size maximum 150 GT (on 2015 Circular Letter of Director General of Capture Fisheries).

Indonesia has been implementing Resolution 15/04 through Minister Decree No. 107 year 2014 concerning National Tuna Management Plan and Minister Regulation No. 12 year 2012 concerning Capture Fisheries in High Seas

Reporting on IMO number:

To allow the necessary time for CPCs to obtain an IMO number for eligible vessels that do not already have one, paragraph 2.b on IMO number is effective as of 1 January 2016. As of this date, CPCs shall ensure that all their fishing vessels that are registered on the IOTC Record of fishing vessels have IMO numbers issued to them. Paragraph 2.b on IMO number does not apply to vessels which are not eligible to receive IMO numbers.





In assessing compliance with the paragraph above, the Commission shall take into account exceptional circumstances in which a vessel owner is not able to obtain an IMO number despite following the appropriate procedures. Flag CPCs shall report any such exceptional situations to the IOTC Secretariat.

As implementation of Minister Regulation No. 56 year 2014, Indonesia has revoked as much as 102 vessels (Purse seine 6 vessels, long line 96 vessels) in Indonesia FMA 572 and 573. Indonesia will develop and replace with new fishing vessels which are built by Indonesia.
