Part A. Describe the actions taken, under national legislation, in the previous year to implement conservation and management measures adopted by the Commission at its NineteenthSession.

- Resolution 15/11 On the implementation of a limitation of fishing capacity of Contracting Parties and Cooperating Non-Contracting Parties.^a
- The required data and information of each vessel according IOTC format are sent to Secretariat in due time.
- Resolution 15/10 On target and limit reference points and a decision framework.
- Management of Tuna fishing is monitored, controlled based on IOTC regulations and fisheries management as an acceptable priciple has been included in Iran fisheries regulations and all management approaches are based on these principles. However, in order to implement these approaches more carefully, we have prepared a national code of conduct for Tuna Fishing Manaegment which is based on this resolution and been announced by Iran Fisheires Organization.
- Resolution 15/09 On a fish aggregating devices (FADs) working group.

- Resolution 15/08 Procedures on fish aggregating devices (FADs) management plan, including a limitation on the number of FADs, more detailed specifications of catch reporting from FAD sets, and the development of improved FAD designs to reduce the incidence of entanglement of non-target species.^a
- Based on this resolution, Iran fisheries are to prepare their managerial plan for FADs.

 Therefore, Iran Fisheries Organization with the help of Purse Seiners proposed a FADs mangment plan. The Table prepared for this activity is to be used for daily reporting (Logsheet) of Purse Seiners.

Each Purse Seiners, averagely install 20-30 FADs at sea and control them via radio buoys. Installation of FADs is according experiments of captain of vessel by climate changes, time and place of installation, sea currents and based on policies of IOTC for member countries. Installation of FADs





and collecting them are according national plans, policies and regulation of Iran besides local and regional regulations (like Tuna Fishing Regulations). It must be noted that industrial fishing vessels which are using purse seine methods in the Oman Sea (EEZ of Islamic republic of Iran) do not use FADs and they only use FADs for international waters fishing activities.

- Resolution 15/07 On the use of artificial lights to attract fish to drifting fish aggregating devices.
- Not applicable for Iran. Basically, there is no fishing with lights among Iran fleet at sea. However, Iran has no fishing vessels that use of artificial lights to attract fish to drifting fish aggregating devices.
- Resolution 15/06 On a ban on discards of bigeye tuna, skipjack tuna, yellowfin tuna, and a
 recommendation for non-targeted species caught by purse seine vessels in the IOTC area of
 competence.
- The Resolution was translated and bulletined among fisheries cooperations especially Purse seine vessels. But as Iran has decleared before, Iranian fishermen have never discarded any small bigeeye, Skipjack, Yellowfin or any other tuna and tuna like species because of graet market of fish in the country. Also maximum period of Iranian vessels navigation time is 45 days and amount of fish are not enough big to occupied the vessels cold storage. In fact Iranian Purse seiners always have enough space in their cold storage to protect fish.
- Resolution 15/05 On conservation measures forstriped marlin, black marlin and blue marlin.
- Iran Fisheries Organization has taken action to the regulations and policies of IOTC resolution. Although there is no target fishery for Billfish.
- Resolution 15/04 Concerning the IOTC record of vessels authorised to operate in the IOTC Area of Competence.^a
- Statistics of authorised vessels and active vessels of Islamic Republic of Iran in IOTC region has been sent to IOTC Secretariat with letter no. 36830 on Feb14, 2016.

Reporting on IMO number:

To allow the necessary time for CPCs to obtain an IMO number for eligible vessels that do not already have one, paragraph 2.b on IMO number is effective as of 1 January 2016. As of this date, CPCs shall ensure that all their fishing vessels that are registered on the IOTC Record of fishing vessels have IMO numbers issued to them. Paragraph 2.b on IMO number does not apply to vessels which are not eligible to receive IMO numbers.

In assessing compliance with the paragraph above, the Commission shall take into account exceptional circumstances in which a vessel owner is not able to obtain an





IMO number despite following the appropriate procedures. <u>Flag CPCs shall report any such exceptional situations</u> to the IOTC Secretariat.

- As we mentioned in email dated Nov 17, 2015(IOTC REF: IRN-00031), In our country for allocating IMO number to fishing vessels there are some specific laws and regulation. Because of these regulations, a major part of our vessels couldn't receive IMO number. Iran Port and Maritime Organization as responsible organization for IMO affairs in Iran has not obliged fishing vessels to get such registration number. But all fishing vessels (except Dhows) have obtained IMO number and it seems that the rest of our fishing vessels (Dhows) according to above resolution, are not eligible to obtain IMO numbe.
- Resolution 15/03 On the vessel monitoring system (VMS) Programme.^a
- As we reported before Iran Fisheries Organization(IFO) had problem to equiped fishing vessels with satelite Vessel monitoring system because of sanction. So IFO equiped all Iranian fishing vessels with offline. After cancelling sanction and in new atmoshmer of our country we have printed a tender in officiall newspaper to start the prolect. While I am writting this report (10th of February 2016) the tendr is under processing and companies are preparing neccessary document to apply their proposals.
- Resolution 15/02 On mandatory statistical reporting requirements for IOTC Contracting Parties and Cooperating Non-Contractign Parties (CPCs).
- Iran Fisheries Organization has taken following steps regarding this resolution:
- Catch Data according to each species, fishing methods and for fishing Pelagic fishes catch & effort including number of vessels and level of effort in previous formats based on fishing vessels class and fishing methods were sent to IOTC
- Biometric data including number of Biometries and average length according to Various Species and their Purseine and Gilnetting Methods were made available to IOTC.
- Resolution 15/01 On the recording of catch and effort data by fishing vessels in the IOTC Area of Competence.
 - According Iran Fisheries Organization's data and statistics software, all Tuna Fishing Vessels are covered in the system and their data is recorded by this system.





The Manual for implementation of 1 and 2 Annexes of this Resolution have been processed and implemented for Purse Seine Vessels were designed based on IOTC format and distributed among Purse Seiners to fill in during 10-day period for trial. But for gillnet Vessels, necessary steps for designing, publication of Manual for Daily Data Collection been underway. In order to supply minimum data available for IOTC, and supplying data by fishing catch and effort according IOTC format, some steps including development of VMS and logbook have been considered. With these alterations we can offer data and statistics by species, month, fishing method, by-catch, and ... preparation until june 30 of 2016.

With regard to some articles of this resolution, IOTC has preapred some special programs for implementation of it and threfore it is necessary support and coordination for supplying training, necessary support and coordination for supplying training, software support be considered by IOTC.

And this was sent to you by letter no. 11045 dated June30, 2015. Regarding coordination with foreign vessels, focal points for Iran have been mendorsed and all vessels can apply for Port Entrance at least Ten days sooner.

- Because of data weaknesses and reciving no reports from fishermen, IFO is going to start a new joint project with NGOs. We hope we will produce quallify information in 2016.
- Resolution 12 /06 On Reducing the Incidental Bycatch of Seabirds in Longline Fisheries
 CPCs shall provide to the Commission, as part of their annual reports, information on how they are implementing this measure and all available information on interactions with seabirds, including bycatch by fishing vessels carrying their flag or authorised to fish by them. This is to include details of species where available to enable the Scientific Committee to annually estimate seabird mortality in all fisheries within the IOTC Area of Competence.
- The Resolution is only applicable to longline vessels and Iran dose not has any Long line active vessels. In fact this resolution is not applicable for Iran.
- Resolution 12/12To Prohibit the use of large-scale driftnets on the high seas in the IOTC Area
 CPCs shall include in their Annual Report a summary of monitoring, control, and surveillance actions related to large-scale driftnet fishing on the high seas in the IOTC area of competence.
- Using long Gillnets is banned according to Article 3-3 National Tuna Fishing Regulation in 2010 and it has been circulated through official network of Iran Fisheries Organization.

 National Regulation for Tuna Fishing Managment of gillnet Vessels with one introduction, 6 Article and 30 items which is based on IOTC regulations in 2010 and it has been circulated through official network of Iran Fisheries Organization. In this regulation, Using long gillnets is banned according to Article 3-3.

- Basically there is no transshipment occurred at sea in Iranian fishing vessels, Because Iran has no active longline fishing vessel in the Indian Ocean Area
- Resolution 15/04 Concerning the IOTC record of vessels authorised to operate in the IOTC Area of Competence.

- take measures to ensure that their AFVs on the IOTC Record keep on board valid certificates
 of vessel registration and valid authorisation to fish and/or tranship;
 Describe the measures:
- All fishing vessels are a unique code and any changes to be updated.
 - ensure that their AFVs on the IOTC Record have no history of IUU fishing activities or that, if those vessels have such a history, the new owners have provided sufficient evidence demonstrating that the previous owners and operators have no legal, beneficial or financial interest in, or control over those vessels; the parties of the IUU incident have officially resolved the matter and sanctions have been completed; or that having taken into account all relevant facts, their AFVs are not engaged in or associated with IUU fishing; Describe the measures:
- The vessels who carry out any infraction against Iranian Fisheries org. legislations and instruction are introduced to both court and especial fishing commission for fisherman infraction investigation.

In fact their IUU infraction registered in the vessels dossier, and they have to pay the penalties and tolerate and sanctions. If a vessels two times carry out infractions during six months their licenses cancelled. In fact any action by fisherman registered in their vessel history.

When a vessels owner is going to sell, the official office change the owner only by introduction letter of IFO so, IFO inform new owner about the vessels condition and probability infraction. However there is a simple but strict procedure for control of vessels IUU.

- ensure, to the extent possible under domestic law, that the owners and operators of their AFVs on the IOTC Record are not engaged in or associated with tuna fishing activities conducted by vessels not entered into the IOTC Record in the IOTC area of competence;
 Describe the measures:
- All vessels information registered computer base program and history of all vessels are very clear for who want to issue license. But regarding those vessels fishing out of territorial waters we have other especial regulations. Registration of these vessels is different from coastal fishing vessels with especially tailored codes of conduct. For example, we have especial codes of conduct for vessels active on IOTC area of competent which is according IOTC regulations for Tuna Fishing
 - take measures to ensure, to the extent possible under domestic law, that the owners of the AFVs on the IOTC Record are citizens or legal entities within the flag CPCs so that any control or punitive actions can be effectively taken against them;
 Describe the measures:





- All fishing vessels in Iran have their own registration number from Iran Port and Maritime Organization and after registration in Iran Fisheries Organization, they obtain their Fishing License, as well. In this License, there is some info on fishing activity and fishing gear and time limit. However Iran Port and Maritime Organization and IFO only issue the require license for Iranian citizen.
