Feedback to Guinea on the level of implementation of IOTC Conservation and Management Measures identified by the CoC12 in 2015.

Feedback: With regards to the level of compliance by Guinea to the decisions of the Commission, the Compliance Committee noted certain issues that required attention. These concerns were communicated to Guinea by the Chair of the Commission in a letter dated 1st May, 2015.

• Has not provided its Report of Implementation, in accordance to Article X of the Agreement.
• Has not provided the completed Compliance Questionnaire, as required by the Rules and Procedure for the Compliance Committee.
• Has not provided its National Report, as required by the decision of SC04.
• Has not provided a response to the Letter of Feedback.
• Has not provided its baseline capacities for tropical tunas and/or swordfish and albacore, as required by Res. 12/11.
• Has not provided its report on import, landing, transshipment of tuna and tuna-like fish products in its ports.

Response: No response to the letter of the Chair of the Commission was provided by Guinea.
