REPORTING REQUIREMENTS

This Resolution, which supersedes Resolution 02/01 of the same title, engenders (almost) exclusive duties for the port State. Its focus is on the central function of the port as a place for inspections and for relevant controls to be exerted over fisheries operations. Large portions of this Resolution are duplicated in more detailed form by Resolution 10/11 on Port State Measures.

There are two reporting requirements for the port State:

- One yearly reporting requirement on submitting a list of foreign vessels that have landed tuna and tuna like species caught in the IOTC area,
- One event-based reporting requirement; in cases where a vessel flying a State's flag is detected in a third party port to have infringed IOTC CMMs.

There is one event-based reporting requirement for the flag State. When the flag State has received full documentation and inspection reports with infringements of IOTC CMMs from the port State, the flag State is required to transmit to the Commission the details of the actions it has taken with respect to the matter (paragraph 5).

Transmit the details of actions taken with respect to the inspection report and details of detected violations received from the port State.

Submit to the flag State and the Commission details of detected violations, including inspection report.

Submit list of foreign fishing vessels that have landed in their ports, indicating full catch details (by weight and species).

REPORTING REQUIREMENTS: FORMAT AND CONTENT

One reporting template has been developed by the Secretariat to facilitate the reporting under this resolution. It concerns the submission of yearly data relating to foreign vessel landings in port. The port inspection report form detailed in Resolution 10/11 must be utilised for consistency in port inspections. The overall report form for basic details of port inspections that revealed alleged infractions has been developed into a word template to facilitate reporting under this resolution.

DETECTED VIOLATIONS OF VESSEL IN PORT

REPORTING REQUIREMENT 1:

TRANSMIT THE DETAILS OF ACTIONS TAKEN WITH RESPECT TO TO THE INSPECTION REPORT AND DETAILS OF DETECTED VIOLATIONS RECEIVED FROM THE PORT STATE

IMPLEMENTATION

- <u>How to report:</u> The flag State CPC should address an official letter to the Commission (through the Secretariat), where it details the matter and the action taken. Supporting evidence should be annexed to the letter, in order to substantiate the facts related therein.
- Reporting format: Official letter with annexes.
- Where to send the information: The letter should be mailed to iotc-secretariat@fao.org

REPORTING REQUIREMENT 2:

SUBMIT TO THE FLAG STATE AND THE COMMISSION DETAILS OF DETECTED VIOLATIONS, INCLUDING INSPECTION REPORT

IMPLEMENTATION

- <u>How to report:</u> The port State CPC should address an official letter to the flag State and the Commission (through the Secretariat in the latter instance), in which it details the matter and the action taken. Supporting evidence should be annexed to the letter, in order to substantiate the facts related therein. A copy of the inspection report is one of the required annexes. Note that an inspection template form is provided in Annex 3 of resolution 10/11.
- Reporting format: Official letter with annexes.
- Where to send the information: The letter should be mailed to iotc-secretariat@fao.org

LIST OF FOREIGN VESSELS THAT HAVE LANDED TUNA AND TUNA LIKE SPECIES

REPORTING REQUIREMENT 3:

SUBMIT A LIST OF FOREIGN FISHING VESSELS THAT HAVE LANDED IN THEIR PORTS, INDICATING FULL CATCH DETAILS

IMPLEMENTATION

- <u>How to report:</u> Port State CPCs ought to fill the template form developed for this purpose. It applies to all designated ports in the country, and to all foreign vessels landing tuna and tuna-like species harvested in the IOTC area of competence.
- Reporting format: The report must be submitted in specified file format. The template spreadsheet form can be accessed under http://www.iotc.org/compliance/reporting-templates
- Where to send the information: The report should be mailed to iotc-secretariat@fao.org
