REPORTING REQUIREMENTS

This Resolution supersedes Resolutions 13/07, 12/07, 10/07, 07/04, 05/04 & 98/04, is targeted to coastal States and is intended to create a record of foreign flagged fishing vessels licensed to fish in the EEZs of coastal CPCs, and a record of country-to-country access agreements. It also serves as a cross check to the IOTC record of authorized fishing vessels under Resolution 15/04 and carrier vessels authorized to receive transhipments from LSLTVs under Resolution 14/06. One of the overall outcomes sought is the strengthening of data collection, and the achievement of more complete statistics on fleets active in the IOTC Area of Competence.

There are four general reporting requirements for all CPCs that issue licenses to foreign flagged vessels to fish in their EEZs under either private access or government to government access agreements and these include: i) list and information on the foreign flag vessels licensed to operate in the EEZ ii) the denial of a license and reasons for such denial; iii) a template of the official coastal State fishing license including terms and conditions of the license, name, contact and official stamp of the Competent Authority who issues such licenses; and iv) prompt notification of any modifications thereto.

WHAT

Submit a list of foreign flag vessels to which licences have been issued during the previous

Submit a list of foreign flag vessels to which licenses have been denied, including reason(s) for such denial.

License template and notification of the Competent Authority to the IOTC Executive Secretary:

- a) The terms and conditions of the coastal State fishing license;
- b) The name of the Competent Authority;
- c) The name and contact of the personnel of the Competent Authority;
- d) The signature of the personnel of the
- Competent Authority;
 e) The official stamp(s) of the Competent Authority.

Prompt notification of any changes to the coastal State fishing license template

WHEN

DEADLINES 15 February every year

DEADLINES

Within 2 months of the entry into force of this Resolution, then promptly when changes occur Further, there is one specific reporting requirement in this Resolution relating to Government to Government access agreements, and require both parties (Coastal State and flag State) to jointly provide information on the access agreement and on the fishing vessels operating under the agreement.

WHO

CPC FLAG STATE AND CPC COASTAL STATE

WHAT

Provide copy of the access agreement and information concerning the access agreements in accordance with paragraph 3, namely:

- a) The CPCs involved in the agreement;
- b) The time period or periods covered by the agreement;
- c) The number of vessels and gear types authorised;

- d) The stock or species authorised for harvest, including any applicable catch limits;
 e) The CPC's quota or catch limit to which the catch will be applied, where applicable;
 f) Monitoring, control, and surveillance measures required by the flag CPC and coastal CPC involved;
 g) Data reporting obligations stipulated in the agreement, including those between the parties involved, as well as those regarding information that must be provided to the Commission;

WHEN

DEADLINE

60 days in advance of the 2013 Commission meeting and following any change to the agreement

REPORTING REQUIREMENTS: FORMAT AND CONTENT

Three reporting form templates are available for submitting the information to the Secretariat. The three templates concern the list of foreign fishing vessels licensed to fish in coastal State EEZ and denied a license, the coastal State fishing license template and information requirements and the government to government access agreement requirements.

REPORTING REQUIREMENT 1: SUBMIT A LIST OF FOREIGN FLAG VESSELS TO WHICH LICENCES HAVE BEEN ISSUED DURING THE PREVIOUS YEAR

IMPLEMENTATION

Items of information to provide per vessel cover: 1) IOTC Number, 2) Vessel name and registration number, 3) IMO number, if available, 4) The flag at the time of issuing the licence, 5) International radio call sign (if any), 6) Vessel type, length, and gross tonnage (GT), 7) Name and address of owner, and/or charterer and/or operator, 8) Main target species, and 9) Period of licence.
