## COMPLEMENTARY ELEMENTS FOR DISCUSSION UNDER ITEM 5 OF THE AGENDA FOR THE COMPLIANCE COMMITTEE

**Prepared by IOTC secretariat** 

At the request of the European Union, the Secretariat has compiled reports received from CPCs and other sources on a number of vessels presumed to have engaged in fishing activities that undermines the IOTC conservation and management measures, since the 13<sup>th</sup> Session of the Commission. Table 1 provides information relating to three vessels that have reportedly engaged in fishing activities in the IOTC Area in contravention of IOTC Resolution(s). Since the reports highlighting the activities of these vessels (see Annex A) were received after the deadline for inclusion on the IOTC Draft IUU Vessels List, the Secretariat is presenting the information in this report for the consideration of CPCs for them to take any action that they may feel is appropriate, at the 14<sup>th</sup> Session of the Commission. Table 2 provides information on vessels for which the Secretariat has not received instructions from the reporting party to include on the IOTC Draft IUU Vessels List. The list of vessels in Table 3 has been compiled after reviewing reports of IOTC Observers deployed through the implementation of the IOTC Regional Observer Programme for monitoring at-sea transhipments.





# RE: South African port state actions regarding Vanuatu-flagged vessel (Balena)

The South African Department of Environmental Affairs branch Marine and Coastal Management (hereafter referred to as the "Department") hereby informs you of serious contraventions of the IOTC management and conservation measures by the Vanuatu-flagged vessel Balena (call sign YJSV8).

In May 2009, the vessel Balena sailed to the nearest port, namely Cape Town Harbour, as a result of mutiny by the crew on board the vessel. The Balena was intercepted and brought under control outside of Cape Town Harbour by various South African governmental agencies. The vessel was escorted to Cape Town Harbour where it was detained following thorough investigation. Despite the skipper declaring that it had tuna and tunalike species on board and was fishing in the Indian Ocean without any authorization from the flag state the Department could not take any legal action against the vessel for this IUU activity. This was due to the skipper declaring the information prior to the South African EEZ permit being issued on 7 May 2009 which allowed the vessel legal access to South African ports. In applying for the EEZ permit, it was declared that the vessel had 2 t bigeye, 1 t yellowfin, 4t albacore, 3t swordfish and 2t of rough skin oilfish, and this was after the vessel had recently discharged product in Namibia in April 2009. After a lengthy legal process the vessel was offloaded and it was found that the skipper under-declared the vessel's cargo manifest by approximately 14.6 t, which was in violation of the EEZ permit conditions. The skipper was subsequently charged.

South African port state actions regarding the Vanuatu-flagged vessel (Balena)

On the 24 August 2009 this matter was settled through a plea and sentence agreement where the skipper, in the employ of Longbow Fishery Co Ltd, admitted guilt and paid a fine of R200 000 and forfeited the underdeclared fish to the state. Although the Department has taken some action against the vessel it is felt that further action is required against the vessel as it had blatantly contravened IOTC resolution [07-02]. In this regard, we note the vessel's activity as a serious offence and should warrant consideration for IUU-listing at the 14<sup>th</sup> Session of the Commission meeting.

It would be greatly appreciated if you could forward this letter to the Vanuatu Fisheries Authority and to all Member Parties of the IOTC.

The mentioned vessel currently flaged under Malaysian Tuna Longline Fishing vessel that authorised under IOTC no 000921 and authorised to fish in Indian Ocean as detail been summited to your good office ealiar this year.

This vessel been registered and licienced under HOOM XIANG INDUSTRIES PRIVATE LIMITED(MALAYSIA) by the registered number of **PPF 771** and valid until 10th December 2009. She have been landing at Tuna Landing site in Pulau Pinang, Malaysia on Januari 2 times, February 1 time and Mac 1 time in year 2009 with combined landing of 157.23 tonnes of tuna species.

At this time this vessel was at Mauritius. For your information, this vessel was equiped with Vessel Monitoring System (VMS) but unfortunately was not function due to electronic problems.

Please advise if this vessel just passing through the EEZ of any country in IOTC area due to bad wheather or any emergency reason, convicted any offences. If possible please give the indicator that this vessel been harvesting tuna or tuna like, red-handed fishing as mentioned in section B of the reporting form. Been in the EEZ of other country jurisdiction does not mean this vessel harvesting fish from that area.

I hope before this recommended for inclusion on IOTC IUU list establish, more evidence should be identified. The authorise body/ personal should boarded the vessel, escorted, apprehended and seized red handed this vessel during the action done.

If any outcome actions such as legal action been taken to this particular vessel, please inform for futher action.

We refer to the letter MARE B-1 OF/el D (2009) dated 22.12.2009, regarding the above matter.

We wish to draw your attention regarding our fishing vessel HOOM XIANG 11 (PPF 771) on the fateful day 9th October 2009, allegedly doing illegal fishing inside the Exclusive Economic Zone of La Reunion.

Inquiries were made on the matter and according to the captain of the vessel, he was doing "an innocent passage" passing through La Reunion EEZ on its way to the fishing ground, when suddenly the vessel developed a mechanical problem on the main engine and stalled. The problem was being repaired by the vessel's engineer. In the meantime the 'wind-anchor' was dropped (lowered) to stop the vessel from drifting further into the EEZ.

Finally the engine was repaired and before leaving, the 'wind-anchor' was hauled and during that hauling time the helicopter hovered above the vessel and took photographs as shown. The photograph which looks like the crew hauling a fish from the long-line was actually hauling the 'wind-anchor', which looked like a fish.

On accusation that the vessel refused to be inspected, its a pity that the captain and the crew do not understand English or French as they are Taiwanese, Philippinos amd Indonesians, and they left not fled.

We hope your are satisfied with our explanation and we apologise for the inconveniences caused.

## REPORT OF VESSEL PRESUMED TO HAVE FISHED IN THE WATER UNDER THE JURISDICTION OF LA REUNION, CONTRARY TO IOTC CONSERVATION AND MANAGEMENT MEASURES

We are referring to your letter dated 28 <sup>th</sup> December 2009 pertaining to the abovesaid matter. The letter from the European Commission dated 22 <sup>nd</sup> December 2009 on the same matter is also referred.

2. It is in our concerned duty to inform you that the owners of vessel Hoom Xiang 11 had denied the said offences and thus provided us with the following factual occurrences;

i. That, on the 6 <sup>th</sup> October 2009 at 1400 Hrs, the vessel bearing the registration number of 'Hoom Xiang 11' had departed from Port Louis heading South-west to the fishing ground. On its journey to the fishing ground, the vessel was intercepted by a helicopter at position Lat. 24° 32' S and Long. 054° 54 E, i.e., after more than 48 hours from the time of departure. Port clearance to depart from Port Louis was obtained from the port authority bearing the no.12187.

ii. That, the said vessel was encountering some mechanical problems need to be mended urgently at position, unfortunately within the jurisdiction of La Reunion.

iii. That, at time of engagement between the vessel and the helicopter, the former was about to leave the area after the completion of the repair works.

iv. That, the vessel was not in any way fishing in the said waters which can be proven by the presence of long-line floats placed at the stern of the vessel and radio-bouys (12 in number) at the port-side of the wheelhouse. This can be seen quiet clearly on the photographs.

v. That, the photograph depicting vessel's crews in the act of hauling something is in fact the action of hauling the 'bag drift anchor' used for the purpose of stabilizing the vessel and to avoid it from drifting away. It is common practice that the bag drift Anchor is never lowered during a fishing operation.

vi. That, the act of leaving the area is not deliberately done to escape from the authority. The captain of the vessel could not understand the language used by the persons in the helicopter thus left the area to continue its journey.

3. While the incidence is regretful and we fully understand the concern of the authority of La Reunion, we would very much appreciate if this matter is being judged based on the facts given. We extend our gratitude and thanks in advance.

We therefore wish to encourage the CPCs to be committed to this resolution.

Following to our previous letter to you Ref. 87/DPT.1/TU.150.D1/I/2010 of January 07, 2010 concerning the above subject, we wish to inform you that we have made a clarification on the above issue both to the Captain and the Boat Owner with the following conclusion:

#### A. Clarification to the Captain:

The boat left Benoa-Bali on August 20, 2008 for fishing at Indian Ocean high seas. On July 2009, the vessel breaks in her journey in Mauritius for refueling and logistics. On September 02, 2009 the vessel left Mauritius back to Indian Ocean high seas for fishing. When fishing was going on, suddenly the main engine and GPS broke, that leads the vessel sail with losing her course or without any direction. On October 08, 2009 the vessel was arrested by France patrol officer (statement of the captain enclosed both in Bahasa Indonesia and English). In this regards, we may conclude that the presence of the vessel, Lingsar 08, in the waters under the jurisdiction of la reunion was not by purpose but by accident.

- B. Clarification to the Boat Owner:
- 1. The vessel, Lingsar 08, has been included on the IOTC Records of Vessels since 11 July 2006 with the identification number: IOTC-003719.
- 2. Identity of the fishing license of the vessels namely: Surat Izin Penangkapan Ikan No. 26.08.0028.04.19449 issued by Indonesia Government on 13 December 2007, valid from 11 January 2008 up to 10 January 2011.
- 3. The vessel, Lingsar 08 and 15 (fifteen persons) Indonesian crews have returned to Indonesia and arrived in Benoa Bali on January 21, 2010 as stated by the Port Administrator in Bali trough a letter No: GM.766/I/I/Ad.Bna-2010 (Copy of the letter both in Bahasa Indonesia and English enclosed).

- 4. France government allowed the vessel, LINGSAR 08 and 15 (fifteen persons) Indonesia Crews return to Indonesia after having paid a penalty (sanction) amount to Euro 75,000 based on the court decision.
- 5. We have received a letter from the owner to propose the vessel, Lingsar 08, not to be included on the IOTC IUU Vessel List.

After providing the above information, Indonesia would suggest IOTC to give due consideration to the settlement taken by the France Government and by the boat owner. We therefore would be very grateful if you could acknowledge receipt of this letter and respond to this issue at your earliest convenience.

I thank you very much for your appreciation and support to further settle this issue in a positive and cooperative manner.




