**Part A.** *Describe the actions taken, under national legislation, in the previous year to implement conservation and management measures adopted by the Commission at its sixteenth Session.*

Resolution 12-01 On The Implementation Of The Precautionary Approach

*Indonesia has adopted Resolution 12-01 through Act Number. 31 year 2004 as amendment by Act Number. 45 year 2009 concerning fisheries. For the implementation, Indonesia adopted with Minister Regulation.*

Resolution 12-02 Data Confidentiality Policy And Procedures

*Indonesia has adopted Resolution 12-02 through Act Number. 31 year 2004 as amendment by Act Number. 45 year 2009 concerning fisheries article 46A.*

Resolution 12-03 On The Recording Of Catch And Effort By Fishing Vessels In The IOTC Area Of Competence

*Indonesia has issued Ministry Regulation Number 18 year 2010 concerning Fishing log book*

Resolution 12-04 On The Conservation Of Marine Turtles (Including in accordance with Article X of the IOTC Agreement, their progress of implementation of the FAO Guidelines and this Resolution)

*Indonesia has adopted Resolution 12-04 by Ministry Regulation Number 12 year 2012 concerning Capture Fisheries Business on the High Seas, article 39, 40, 42.*

*For regulation on national jurisdiction, Indonesia has adopt Resolution 12-04 by Ministry Regulation Number 30 year 2012 concerning Capture Fisheries Business on Indonesia Fisheries Management Area, article 73-74 on release of marine turtles.*

*On data collection and monitoring purpose, Indonesia has include spesies of marine turtles on the log book. Indonesia has issued Ministry Regulation Number 18 year 2010 concerning fishing log book. Based on the log book and observer report, on 2012 there was no catches of marine turtle.*

*Indonesia has prepared draft of National Plan of Action concerning marine turtle.*

*Indonesia has also conducted research on marine turtle.*

*According to the observer regulation, Ministry Regulation Number 1 year 2013 concerning observer, on the attachment of observer report, observer should check the vessel to carry de-hookers. However, Indonesia has not yet regulate that every vessel should carry de-hookers and line cutters.*

Resolution 12-05 On Establishing A Programme For Transhipment By Large-Scale Fishing Vessels

*Indonesia has been implementing Resolution 12/05.*

*During 2012, there is only 1 (one) fishing vessel which was reported join the transhipment at sea programme. This fishing vessels is LEON.*

*Indonesia has issued Ministry Regulation Number 12 year 2012 concerning Capture Fisheries Bussiness on the High Seas, article 30-31 which was stipulated procedure of transhipment at sea and transhipment at port programme. On Article 52 also stipulated procedure for the report. Transhipment record in 2012 is as attached.*

Resolution 12-06 On Reducing The Incidental Bycatch Of Seabirds In Longline Fisheries

In force in July 2014

Resolution 12-07 Concerning A Record Of Licensed Foreign Vessels Fishing For IOTC Species In The IOTC Area Of Competence And Access Agreement Information

*Resolution 12-07 is not applicable for Indonesia. Indonesia only regulate license for Indonesia fishing vessels.*

Resolution 12-08 Procedures On A Fish Aggregation Devices (FADs) Management Plan

*Indonesia has issued Regulation of the Minister of Marine Affairs and Fisheries Number: 30 year 2004 regarding FAD and Indonesia has prepared to revise this regulation.*

*Indonesia also has issued Minister Regulation No. 02 year 2011 concerning fishing lane and placement of fishing gear and support fishing gear which was regulated placement of FAD.*

Resolution 12-09 On The Conservation Of Thresher Sharks (Family Alopiidae) Caught In Association With Fisheries In The IOTC Area Of Competence

*On legislative measures, Indonesia has adopted Resolution 12-04 by Ministry Regulation as follow:*

- a) Ministry Regulation Number 12 year 2012 concerning Capture Fisheries Bussiness on the High Seas, article 39, 40, 42-44.*
- b) Ministry Regulation Number 30 year 2012 concerning Capture Fisheries Bussiness on Indonesia Fisheries Management Area, article 73, paragraph 2 to release thresher shark. The regulation in Bahasa is as attached.*
- c) Ministry Regulation Number 18 year 2010 concerning fishing log book, which was if any catches of thresher should by record in the log book. The regulation in Bahasa is as attached.*

*Indonesia also published conservation poster of thresher shark which was distributed to fishing port, Dinas marine and fisheries at province and distric, fishing industry;*

*Indonesia has perpared draft of National Plan of Action concerning shark*

Resolution 12-10 To Promote Implementation Of Conservation And Management Measures Already Adopted By IOTC

*Indonesia has issued national Act and minister regulation which were regulated concerning conservation and management measure on fisheries.*

**Resolution 12-11 On The Implementation Of A Limitation Of Fishing Capacity Of Contracting Parties And Cooperating Non-Contracting Parties**

*Indonesia has issued national Act and minister regulation which were regulated concerning limitation of fishing capacity*

*Ministry Regulation Number 12 year 2012 concerning Capture Fisheries Bussiness on the High Seas,*

*Ministry Regulation Number 30 year 2012 concerning Capture Fisheries Bussiness on Indonesia Fisheries Management Area.*

**Resolution 12-12 To Prohibit The Use Of Large-Scale Driftnets On The High Seas In The IOTC Area (Including a summary of monitoring, control, and surveillance actions related to large-scale driftnet fishing on the high seas in the IOTC Area of Competence)**

*Indonesia has issues Minister Regulation No. 02 year 2011 concerning fishing lane and placement of fishing gear and support fishing gear which was stipulates that maximum length of large scale driftnet is 2.5 km enforced not only in the water under Indonesia national jurisdiction but including in the high seas.*

*Indonesia only give fishing license on the high seas for long line fisheries in the Indian Ocean and Pacific Ocean and purse seine fisheries only in the pacific ocean. Until 2012, there is no fishing vessels using large scale driftnets.*

**Resolution 12-13 For The Conservation And Management Of Tropical Tuna Stocks In The IOTC Area Of Competence (Including a summary of VMS records related to their fleet operation in the previous year for the consideration of the Compliance Committee)**

*According to Resolution 10/01, on 2010 and 2011 Indonesia has informed formally to related government institution and Tuna Fisheries Association concerning closure area and time which was stipulated on Resolution 10/01.*

*On 2012, Indonesia has also informed Resolution 12/13 formally to related government institution and Tuna Fisheries Association.*

*On the legislative measures, Indonesia has issued Ministry Regulation Number 12 year 2012 concerning Capture Fisheries Bussiness on the High Seas, article 45 which was stipulated restriction for fishing activity on closure fishing seasons and area which was regulated by RFMO.*

*Indonesia also control Indonesia fishing vessels on closure area using VMS. Based on the VMS record there were no Indonesia fishing vessels operated on the closure area. Indonesia will report the summary of VMS record for the area closure in seperate letter.*

**Recommendation 12/15 On The Best Available Science**

*Not Applicable for Indonesia. Indonesia always involve in Scientific Committee Meeting and also improve data collection and submission to IOTC.*

**Part B.** *Describe the actions taken, under national legislation, to implement conservation and management measures adopted by the Commission in previous Sessions, and which have not been reported previously.*

1. Resolution 01/02 - Relating to control of fishing activities - Indonesia has issued regulation to control fishing activities since 1970. On the high seas, Indonesia has issued Ministerial Regulation Number 12 year 2012, article 57 which was stipulated that every fishing vessels and carrier vessels should have fishing license (for fishing vessel), carrier license (for carrier vessel) on board. Beside the license, the vessels should have on board Sailing Approval Certificate, fishing log book, Sea Worthiness Certificate. Ministry Regulation Number 30 year 2012 concerning Capture Fisheries Business on Indonesia Fisheries Management Area.

Indonesia has not yet regulation on the system used to mark fishing gear. However, Indonesia has initiated to prepare the draft concerning mark of fishing gear.

2. Res. 05/03 - Port inspection programme - During 2012, there was only 1 (one) foreign vessels which was entered to Indonesia fishing port, namely No. 353, ORYONG, Korean Flagged Vessel. According to the PSM procedure, this vessels has fulfilled annex A Agreement of PSM. The result of port inspection by Indonesia officer stipulated based on Annex C Agreement of PSM.

3. Res. 10/11 On Port State Measures To Prevent, Deter And Eliminate Illegal, Unreported And Unregulated Fishing - Indonesia has informed to IOTC 5 (five) fishing ports of Indonesia which was designated for PSM activities. During 2012, there was only 1 (one) foreign vessels which was entered to Indonesia fishing port, namely No. 353, ORYONG, Korean Flagged Vessel. According to the PSM procedure, this vessels has fulfilled annex A Agreement of PSM. The result of port inspection by Indonesia officer stipulated based on Annex C Agreement of PSM.

**Part C.** Data and information reporting requirements for CPCs to be included in this report (please refer to the *section March 2013 of the Guide on data and information reporting requirements for Members and Cooperating Non-contracting Parties*).

- Resolution 01/06 *Concerning the IOTC bigeye tuna statistical document programme*

CPCs which export bigeye tuna shall examine export data upon receiving the import data from the Secretary, and report the results to the Commission annually.

During 2011 and 2012, there were 2 (two) fishing ports that was reported IOTC Bigeye Statistical which is Nizam Zachman Jakarta Ocean Fishing Port and Pengambangan Archipelagic Fishing Port. From those data, we have examine with the import data from the Secretary. The result of the examination is as attached.

For validation purpose, Indonesia has issued Director General Decree Number 5 year 2013 concerning validation officer and Indonesia also has been reported the validation officer to IOTC Secretariat.

- Recommendation 05/07 *Concerning a management standard for the tuna fishing vessels*

The CPC flag states which issues licenses to their AFVs should report annually to the Commission all measures taken to meet the minimum management standards when they issue fishing licenses to their “authorised fishing vessels”.

Indonesia already have the standard for fishing activities from the license process until reporting. On the legislative measures, Indonesia has issued regulation through Ministry Regulation as follow:

a) Ministry Regulation Number 12 year 2012 concerning Capture Fisheries Bussiness on the High Seas, article 5 - 12 addressing fishing license process in the high seas. Article 30-31 also regulated concerning procedure of transshipment at sea and transshipment at port programme and Article 52 for the report.

b) Ministry Regulation Number 30 year 2012 concerning Capture Fisheries Bussiness on Indonesia Fisheries Management Area, article 11 - 28 addressing fishing license process in FMA Indonesia.

c) Ministry Regulation Number 18 year 2010 concerning fishing log book.

d) Ministry Regulation Number 5 year 2007 concerning Vessel Monitoring System.

e) Ministry Regulation Number 7 year 2010 addressing establishment of document for operation of fishing vessel

- Resolution 10/06 On Reducing the Incidental Bycatch of Seabirds in Longline Fisheries

CPCs shall provide to the Commission, as part of their annual reports, information on how they are implementing this measure and all available information on interactions with seabirds, including bycatch by fishing vessels carrying their flag or authorised to fish by them. This is to include details of species where available to enable the Scientific Committee to annually estimate seabird mortality in all fisheries within the IOTC Area of Competence.

Indonesia has adopted Resolution 12-04 by Ministry Regulation Number 12 year 2012 concerning Capture Fisheries Business on the High Seas, article 39-44.

Indonesia has adopted Resolution 12-04 by Ministry Regulation Number 12 year 2012 concerning Capture Fisheries Business on the High Seas, article 39, 40, 41, 42.

For regulation on national jurisdiction, Indonesia has adopt Resolution 12-04 by Ministry Regulation Number 30 year 2012 concerning Capture Fisheries Business on Indonesia Fisheries Management Area, article 73-74 on release of sea bird.

On data collection and monitoring purpose, Indonesia has include spesies of seabird on log book. Indonesia has issued Ministry Regulation Number 18 year 2010 concerning fishing log book. Based on the log book and observer report, on 2012 there was no catches of sea bird.

Indonesia has also conducted research on sea bird.

For the Implementation of mitigation measures south of 25°S, based on VMS there were no Indonesia fishing vessels operated in south of 25°S.

- Resolution 10/10 Concerning market related measures

For CPCs that import tuna and tuna-like fish products, or in whose ports those products are landed or transhipped, should report, a range of information (e.g. information on vessels / owners, product data (species, weight), point of export) annually.

Indonesia collect the domestic market of tuna by level of tuna consumption approach in domestic and categories as Tuna/Frigate Tuna/Skipjack. Consumption of Tuna/Frigate Tuna/Skipjack, divided into 2 (two) product, fresh and salted/diawetkan. from 2008 - 2011, domestic market of tuna is as follow:

- Resolution 11/04 On a Regional observer scheme

CPCs shall provide to the Executive Secretary and the Scientific Committee annually a report of the number of vessels monitored and the coverage achieved by gear type in accordance with the provisions of this Resolution.

Indonesia has issued Ministry Regulation Number 01 year 2013 concerning observer scheme.

Since 2006, National Observer Programme has been initiated by conducting the training programme for the observer. During 2006 - 2012, Indonesia has trained 58 persons of ex-fishing vessel crew and 34 government employees. On 2012, Indonesia has deployed 14 observers for 14 fishing vessels on November 2012. Indonesia will report the result of observer programme in 2012 by the 1st of April 2013. The data collected by observer are available in Excel format.
