## <u>Feedback to European Union on the level of implementation of IOTC Conservation and</u> <u>Management Measures identified by the CoC09 in 2012.</u>

**Feedback:** With regards to the level of compliance by European Union to the decisions of the Commission, the Compliance Committee noted certain issues that required attention. These concerns were communicated to European Union by the Chair of the Commission in a letter dated 26<sup>th</sup> April, 2012.

• Resolution 10/02 (Minimum reporting requirements): Noting the difficulties faced by some Member States of the EU to provide data for longline and coastal fisheries (Catch and effort, size frequency and bycatch species data), the CoC **WELCOMED** the EU commitment to improve the reporting in the intersessional period.

**Response:** The European Union provided its response to the letter of the Chair of the Commission on  $25^{\text{th}}$  May, 2012.

## <u>Current issues on the level of implementation by the European Union of IOTC</u> <u>Conservation and Management Measures identified for discussion in the CoC10 in 2013.</u>

Having reviewed the 2013 Compliance Report for the European Union, the Chair of the Compliance Committeehas identified the following significant non-compliance issues for discussion.

- Has not fully reported catch and effort and size frequency data, as required by Resolution 10/02, for some segments of its fleets.
- Has not provided the mandatory report on transhipments in port, as required by Res. 12/05.
