# PROPOSED SCHEDULE OF IOTC WORKING PARTY AND SCIENTIFIC COMMITTEE MEETINGS FOR 2014 AND TENTATIVELY FOR 2015

## PURPOSE

To provide the Scientific Committee (SC) with the proposed list of dates and locations for each Working Party and Scientific Committee meeting to be held in 2014 and tentatively for 2015, for its consideration.

## BACKGROUND

The number of IOTC working party meetings has increased in recent years and the current length and timing of these meetings continues to stretch the limited resources of the IOTC Secretariat and CPCs alike. As such, there is a clear need to increase the level of efficiency (e.g. monetary and time) of the IOTC scientific process. In addition, it has become necessary to plan two years in advance so as to give potential hosts enough time to incorporate meeting costs into their budgets.

## DISCUSSION

In recent years, there has been substantial discussion among participating IOTC scientists aimed at encouraging, wherever it is logical/feasible, the consolidation of IOTC meetings thereby reducing the financial and logistical burden upon the IOTC. Discussion has revolved around what would be the most sensible combination of working party meetings and the timing of those meetings, taking into account data reporting deadlines and other timing demands. It has been suggested that where feasible meetings should be held in localities most relevant to the participating CPCs. This would help increase the profile of the work that the IOTC is undertaking by exposing scientists from the region to fisheries matters most relevant to their own fleets.

The need for forward planning is highlighted by the fact that many of those invited to attend IOTC meetings as Invited Experts have indicated that their schedules are often planned more than 12 months in advance. As such, there is a clear need to secure meeting dates and locations well in advance.

In identifying potential venues and dates for IOTC meetings, other key international meetings in 2014 need to be considered:
