

IDENTIFICATION OF REPEATED INFRINGEMENTS UNDER THE REGIONAL OBSERVER PROGRAMME

Prepared by IOTC Secretariat, 26 April 2014

In line with 1) the requirement of IOTC Resolution 12/05 *On establishing a programme for transshipment by large-scale fishing vessels*, and 2) the recommendation made by the Compliance Committee at its 10th Session:

53. The CoC **RECOMMENDED** that the Secretariat follow, from one year to the next, the potential infringement cases identified so as to allow the CoC to identify repeated cases of infringement.

This document provides a summary of repeated cases of infringements of IOTC regulations by LSTLVs/carrier vessels, as recorded by observers deployed under the Programme during 2013.

Identification of repeated infringements by LSTLVs in 2013.

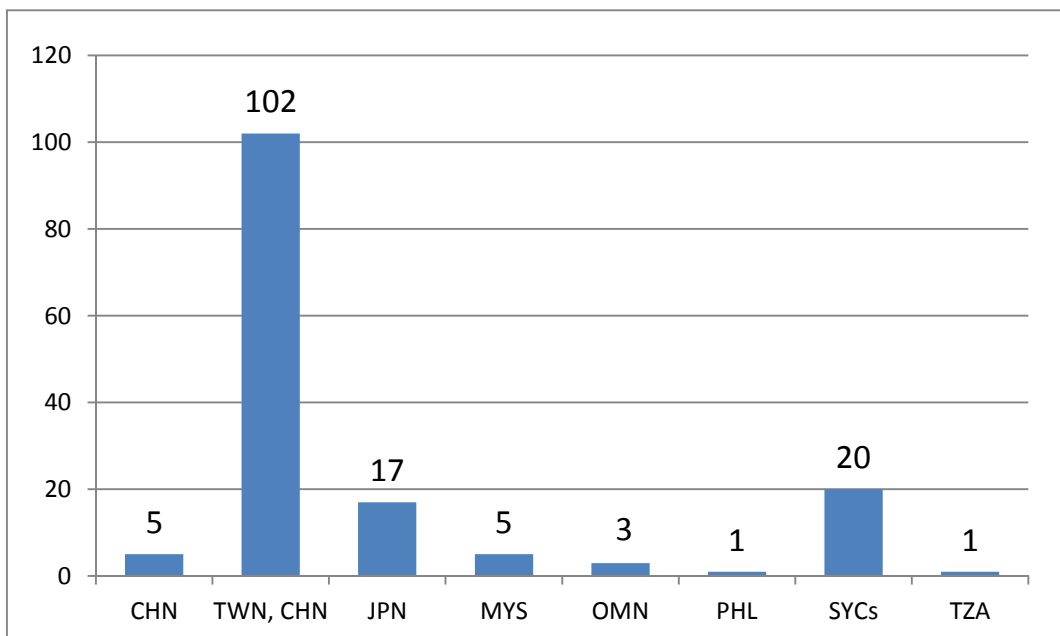


Figure 1: Number of LSTLVs by fleet with repeated infringements in 2013.

Seven fleets have a record of repeated infringements and four fleets have no record of repeated infringement in 2013 (Belize, Indonesia, Korea and Thailand). The numbers of LSTLVs with repeated infringements in 2013 are presented by fleets in Figure 1.

Identification of repeated infringements by LSTLVs in 2013 that have record of infringement in 2012.

Four fleets have LSTLVs with a record of repeated infringements in 2013 that have record of infringements in 2012:

- One hundred and two LSTLVs of the fleet of Taiwan, Province of China have been identified as repeated offender in 2013. Thirty four of those 102 vessels have a record of possible infractions in 2012.
- Seventeen LSTLVs of the fleet of Japan have been identified as repeated offender in 2013. Two of those 17 LSTLVs have a record of possible infractions in 2012.
- Three LSTLVs of the fleet of Oman have been identified as repeated offender in 2013. Two of those 3 vessels have a record of possible infractions in 2012.
- Twenty LSTLVs of the fleet of Seychelles have been identified as repeated offender in 2013. Five of those 20 vessels have a record of possible infractions in 2012.

Four fleets have LSTLVs with a record of repeated infringements in 2013, but did not tranship in 2012 or there is no record of infringement in 2012:

- Five LSTLVs of the fleet of China have been identified as repeated offender in 2013.
- Five LSTLVs of the fleet of Malaysia have been identified as repeated offender in 2013.
- One LSTLVs of the fleet of Philippines has been identified as repeated offender in 2013.
- One LSTLV of the fleet of Tanzania has been identified as a repeated offender in 2013.

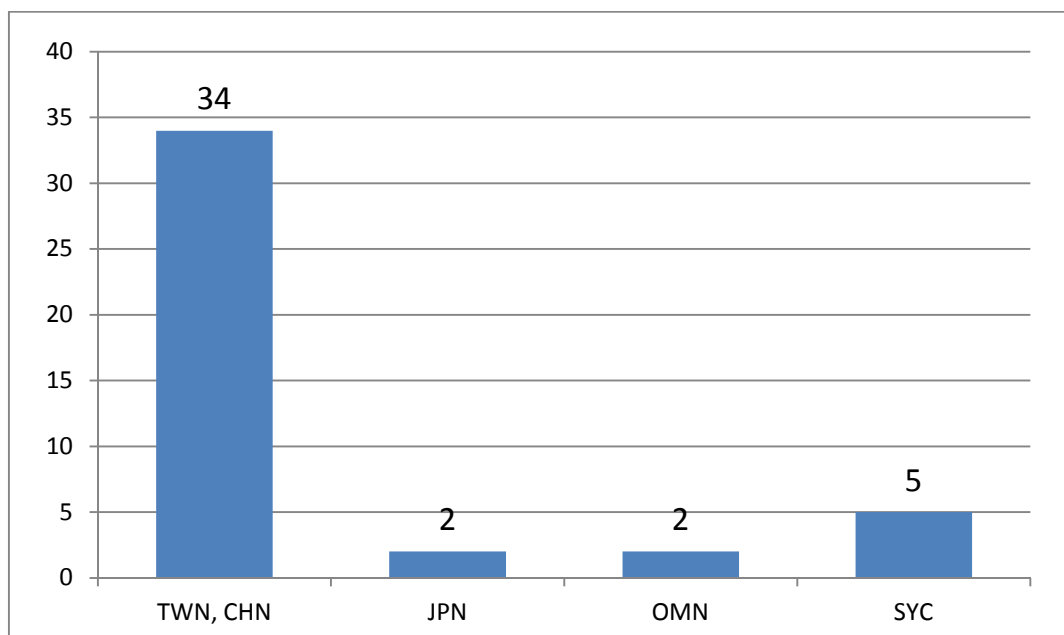


Figure 2: Number of LSTLVs by fleet with repeated infringements in 2013 and record of infringement in 2012.

The numbers of LSTLVs with repeated infringements in 2013 and with a record of infringements in 2012 are presented by fleet in Figure 2.
