Feedback to South Africa on the level of implementation of IOTC Conservation and Management Measures identified by the CoC10 in 2013.

Feedback: With regards to the level of compliance by South Africa to the decisions of the Commission, the Compliance Committee noted certain issues that required attention. These concerns were communicated to South Africa by the Chair of the Commission in a letter dated 10th May 2013.

- Has not reported size frequency data for the coastal and longline fisheries, as required by Res. 10/02.
- Has not provided the mandatory VMS report on the progress and implementation, as required by Res. 06/03.
- Has not provided the mandatory report on transhipments in port, as required by Res. 12/05.
- Has not provided the mandatory reports on port inspection programme landing of foreign vessels in CPC ports as required by Res. 05/03.
- Has not provided the mandatory report on comparison of export and import of Bigeye tuna, as required by Res. 01/06.

Response: South Africa provided a response to the letter of the Chair of the Commission on 22 August 2013.

<u>Current issues on the level of implementation by South Africa of IOTC Conservation and</u> <u>Management Measures identified for discussion in the CoC11 in 2014.</u>

Having reviewed the 2014 Compliance Report for South Africa, the Chair of the Compliance Committee has identified the following significant non-compliance issues for discussion.

- Has not provided the implementation report, as required by the IOTC Agreement.
- Has not implemented the marking of fishing gears, as required by resolution 13/02.
- Has not provided information on the official authorisation to fish outside National Jurisdictions, as required by resolution 13/02.
- Has not provided the official fishing logbooks, as required by resolution 13/03.
- Has not provided information on legal and administrative measures to implement the area Closure, as required by Resolution 12/13
- Has not provided a list of active vessels in 2013, as required by Resolution 10/08.
- Has not provided a FAD management plan, as required by Resolution 13/08.
- Has not reported size frequency data for the coastal and longline fisheries, as required by Res. 10/02.
- Has not provided the mandatory VMS report on the progress and implementation, as required by Res. 06/03.
- Has not provided the mandatory summary of VMS record, as required by Res. 12/13.
- Has not provided the mandatory report on transhipments in port, as required by Res. 12/05.
- Has not transposed the prohibition on oceanic whitetip sharks (*Carcharhinus longimanus*) into national legislation, as required by Res. 12/05.
- Has not provided the mandatory report on comparison of export and import, as required by Res. 01/06.
- Has not provided the mandatory reports on port inspection programme landing of foreign vessels in national ports as required by Res. 05/03.
- Has not provided information on competent authority and period of notice of designated ports, as required by Res. 10/11.
- Has not provided the mandatory report on import, landing, transhipment of tuna and tunalike fish products in ports, as required by Res. 10/10.
