Indonesia has agreed and support the resolution 13/10. And Indonesia through RCFMC has actively participated in all working party and scientific committee of IOTC, and support available data information and analysis related to the assessment and review on interim target and limit reference points, harvest control rules (HCRs) together with former scientists IOTC

11. Resolution 13/11 On a ban on discards of bigeye tuna, skipjack tuna, yellowfin tuna, and a recommendation for non-targeted species caught by purse seine vessels in the IOTC Area of Competence

Indonesia will develop a national legislation to retain on board all catch of purse seiner as well as not to deploy gear when the fish hold space can not accommodate additional catches

Additional information:

Based on data from the IOTC Secretariat (IOTC website), there were 2 (two) importing countries of big eye from Indonesia that has submitted IOTC Big Eye statistical document to IOTC Secretariat in 2013, namely Korea and European Union. From the document, there were 140 kg of bigeye tuna imported by Korea and 479.233 kg imported by UE.

From examination to IOTC Big Eye statistical document issued by Indonesia, we may conclude that the total volume of exporting bigeye in 2013 was estimated about 2.878.295 kg. There were 6 (six) export destination countries namely China, Japan, Korea, Portugal, Spain, USA with the total volume was about 660.996 kg. By assuming that the volume of Big Eye exported to UE as much as 479.233, then the destination country for the rest of 1.738.066 kg need to be identified.

- Recommendation 05/07 Concerning a management standard for the tuna fishing vessels

The CPC flag states which issues licenses to their AFVs should report annually to the Commission all measures taken to meet the minimum management standards when they issue fishing licenses to their "authorised fishing vessels".

Management Standard for tuna fishing vessels is being developed

- Resolution 10/06 On Reducing the Incidental Bycatch of Seabirds in Longline Fisheries

CPCs shall provide to the Commission, as part of their annual reports, information on how they are implementing this measure and all available information on interactions with seabirds, including bycatch by fishing vessels carrying their flag or authorised to fish by them. This is to include details of species where available to enable the Scientific Committee to annually estimate seabird mortality in all fisheries within the IOTC Area of Competence.

Indonesia has developed domestic rule to mitigate the incidental bycatch of seabirds in longline fisheries. Information of seabirds interaction in longline fisheries will be collected by observer on board.

- Resolution 10/10 Concerning market related measures

Indonesia has developed a ministerial regulation No 01/2013 on Observer on Board Program. Recruitment and training of observer has been initiated by 2013 and trial deployment by 2014.

- Resolution 12/04 On marine turtles

CPCs shall report to the Commission, in accordance with Article X of the IOTC Agreement, their progress of implementation of the FAO Guidelines and this Resolution.

Information of interaction marine turtles in longline will be collected by observer on board.

- Resolution 12/05 On establishing a programme for transhipment by large-scale fishing vessels

During 2013 there were 5 (five) fishing vessels conducting transshipment at sea with total volume 186.909 kg. There were 2 (two) fishing vessels, namely Mahkota Abadi 08 and Maya 09 conducting transshipment in port with volume 106.293 kg. Meanwhile, other 3 (three) fishing vessels, Karya Wijaya 107, Melati 02 and Permata 31 were conducting transshipment at sea with volume 80.616 kg
