Feedback to Tanzania on the level of implementation of IOTC Conservation and Management Measures identified by the CoC10 in 2013.

Feedback: With regards to the level of compliance by Tanzania to the decisions of the Commission, the Compliance Committee noted certain issues that required attention. These concerns were communicated to Tanzania by the Chair of the Commission in a letter dated 10th May 2013.

<ul style="list-style-type: none">• Resolution 10/02 (Minimum reporting requirements): While noting the progress that Tanzania has made over the past year in implementing and improving its data collection and reporting systems, the CoC noted that Tanzania is non-compliant with the data reporting requirements; in particular has not reported nominal catch, catch and effort, size frequency data and bycatch data for coastal fisheries and the longline fishery. The CoC ENCOURAGED Tanzania to make further improvements in data collection and reporting during the intersessional period.
<ul style="list-style-type: none">• Resolution 07/02 (Record of authorised vessels): Noting that Tanzania has not provided information on GT for vessels above 24 meters, the CoC ENCOURAGED Tanzania to provide as soon as possible the required information.
<ul style="list-style-type: none">• Has not implemented the requirements of IOTC Conservation and Management Measures on seabirds, thresher sharks and large scale driftnets into domestic legislation as required by Resolutions 10/06, 12/09 and 12/12, the CoC URGED Tanzania to transpose these Conservation and Management Measures into domestic legislation as soon as possible.
<ul style="list-style-type: none">• Resolution 11/04 (Regional Observer Scheme): Noting that Tanzania has not implemented an observer scheme as required by this resolution and that Tanzania expressed its commitments to fully implement the scheme, the CoC ENCOURAGED Tanzania to continue towards full implementation during the intersessional period.
<ul style="list-style-type: none">• Resolution 10/11 (On port State measures to prevent, deter and eliminate illegal, unreported and unregulated fishing): Noting that Tanzania has not provided the list of the designated ports, the name of the competent authority, the notification periods notice and the inspection reports, the CoC URGED Tanzania to report the information as soon as possible.
<ul style="list-style-type: none">• Response to the letter of feedback: Noting that Tanzania has not provided a response to the letter of feedback, the CoC URGED Tanzania to provide a response to the letter of feedback of 2012.

Response: No response to the letter of the Chair of the Commission was provided by Tanzania.

Current issues on the level of implementation by Tanzania of IOTC Conservation and Management Measures identified for discussion in the CoC11 in 2014.

Having reviewed the 2014 Compliance Report for Tanzania, the Chair of the Compliance Committee has identified the following significant non-compliance issues for discussion.

<ul style="list-style-type: none">• Has not implemented the legal and administrative measures to implement the area Closure, as required by Resolution 12/13.
<ul style="list-style-type: none">• Has not provided the list of vessels for Tropical Tuna during 2006 as required by Resolution 12/11.
<ul style="list-style-type: none">• Has not provided the summary of VMS record, as required by Resolution 12/13.
<ul style="list-style-type: none">• Has not reported nominal catch, catch and effort, size frequency data, and bycatch data for coastal fisheries and the longline fishery as required by Resolution 10/02.
<ul style="list-style-type: none">• Has not reported catch and effort data for foreign fishing vessels, as required by Resolution 10/02.
<ul style="list-style-type: none">• Has not provided the list of authorised carrier vessels and the report on results of investigations on possible infractions as required by Resolution 12/05.
<ul style="list-style-type: none">• Has not implemented an observer programme and sampling scheme as required by Resolution 11/04.
