<u>Feedback to Senegal on the level of implementation of IOTC Conservation and</u> <u>Management Measures identified by the CoC10 in 2013.</u>

Feedback: With regards to the level of compliance by Senegal to the decisions of the Commission, the Compliance Committee noted certain issues that required attention. These concerns were communicated to Senegal by the Chair of the Commission in a letter dated 10th May 2013.

- Senegal has not had any fishing presence in the IOTC Area for the last 6 years.
- Has kept on the IOTC Record of Authorised Vessels some vessels with invalid authorisation periods; some information missing or not according to IOTC standards.

Response: Senegal provided its response to the letter of the Chair of the Commission on 23rd March 2014.

<u>Current issues on the level of implementation by Senegal of IOTC Conservation and</u> <u>Management Measures identified for discussion in the CoC11 in 2014.</u>

Having reviewed the 2014 Compliance Report for Senegal, the Chair of the Compliance Committee has identified the following significant non-compliance issues for discussion.

- Senegal has not had any fishing presence in the IOTC Area for the last 6 years.
- Has not provided its implementation report as required by the IOTC Agreement.
- Has not provided a FDP at IOTC standard, mandatory information missing: GT and origin of vessels, as required by resolution 12/11.
- Has not provided a list of vessels for Tropical Tuna during in 2006 at IOTC standard, , as required by resolution 12/11.
- Has provided the mandatory report on import, landing, transhipment of tuna and tuna-like fish products in ports, as required by resolution 10/10.
