Part B. Describe the actions taken, under national legislation, to implement conservation and management measures adopted by the Commission in previous Sessions, and which have not been reported previously.

Belize has ensured the implementaion of all relevant conservation and management measures adopted by the Commission at the last annual meeting. This includes the implementation of new National Fisheries Legislation, implementation of new licensing requirements, the revision of Belize's National Plan of Action for IUU, the implementation of a National Inspection and Observer Programme. All other resolutions relating to our long line fleet during the year 2014 has been respected. Belize has taken the decision to withdraw from the IOTC area of competence for the coming year, until further notice.

• Resolution 01/06 Concerning the IOTC bigeye tuna statistical document programme

Additional information:

As Belize is not a coastal state within the IOTC Area of competence, it does not import or export bigeye tuna within this area.

• Recommendation 05/07 Concerning a management standard for the tuna fishing vessels

The CPC flag states which issues licenses to their AFVs should report annually to the Commission all measures taken to meet the minimum management standards when they issue fishing licenses to their "authorised fishing vessels".

Belize submits a list of "authorized fishing vessels' (AFVs) annually in acordance with this Recommendation; and further reports any changes to its list of AFVs during the course of the year as the list may change.

• Resolution 10/06 On Reducing the Incidental Bycatch of Seabirds in Longline Fisheries

CPCs shall provide to the Commission, as part of their annual reports, information on how they are implementing this measure and all available information on interactions with seabirds, including bycatch by fishing vessels carrying their flag or authorised to fish by them. This is to include details of species where available to enable the Scientific Committee to annually estimate seabird mortality in all fisheries within the IOTC Area of Competence.

This resolution is duly noted and is respected. A legally binding Fishing Vessel Circular has been issued and disseminated to all Belize Flagged fishing vessels to mitigate the incidental by-catch of sea-birds in long line fisheries. Belize submits its report of interaction with sea-birds annually, the last of which was submitted to the Commission on 28/11/2012. A list of mitigation measures utilized by Belize Flagged vessels have also been submitted to the Commission.

• Resolution 10/10 Concerning market related measures

• Resolution 11/04 On a Regional observer scheme

CPCs shall provide to the Executive Secretary and the Scientific Committee annually a report of the number of vessels monitored and the coverage achieved by gear type in accordance with the provisions of this Resolution.

As Belize is not a Coastal State within the IOTC Area of Competence, we do not import tuna or tuna-like species within this area. The revision of Belize's National Legislation has taken into consideratoin the requirements of this resolution and its passage will provide the legal framework for the implementation of a National Observer Scheme. This Administration has developed an observer programme for our entire fleet.

• Resolution 12/04 On marine turtles

CPCs shall report to the Commission, in accordance with Article X of the IOTC Agreement, their progress of implementation of the FAO Guidelines and this Resolution.

This resolution is duly noted and is respected. A legally binding Fishing Vessel Circular has been issued and disseminated to all Belize Flagged fishing vessels to mitigate the incidental by-catch of sea turtles.

• Resolution 14/06 On establishing a programme for transhipment by large-scale fishing vessels

Each flag CPC of the LSTV shall include in its annual report each year to IOTC the details on the transhipments in ports by its vessels (Name of LSTV, IOTC Number, name of carrier vessel, species and quantity transhipped, date and location of transhipment). [A template report exists].

Belize has in place a protocol for transhipment at sea in accordance with this resolution. Our transhipment protocol is currently being reviewed and will be revised to strenghten our control over transhipment activities. However, our long line fleet did not conduct any transhipments through out the year 2014.

• Resolution 12/12 To Prohibit the use of large-scale driftnets on the high seas in the IOTC Area

CPCs shall include in their Annual Reports a summary of monitoring, control, and surveillance actions related to large-scale driftnet fishing on the high seas in the IOTC area of competence.

A legally binding Fishing Vessel Circular has been issued and disseminated to all Belize Flagged vessels which prohibits the use of large-scale driftnets.

• Resolution 13/04 On the conservation of cetaceans

CPCs shall report, in accordance with Article X of the IOTC Agreement, any instances in which cetaceans have been encircled by the purse seine nets of their flagged vessels.

Belize registered vessels in operation in the IOTC area of computence are long line vessels and do not use purse seine gears for fishing activities. A leggaly binding fishing vessel circular has been issued and disseminated to all Belize flagged vessels on the conservation of cetaceans.

• Resolution 13/05 On the conservation of whale sharks (Rhincodon typus)

CPCs shall report, in accordance with Article X of the IOTC Agreement, any instances in which cetaceans have been encircled by the purse seine nets of their flagged vessels.

Belize registered vessels in operation in the IOTC area of computence are long line vessels and do not use purse seine gears for fishing activities.

• Resolution 14/05 Concerning A Record Of Licensed Foreign Vessels Fishing For IOTC Species In The IOTC Area Of Competence And Access Agreement Information





For Government to Government access agreement in existence prior to the entry into force of this resolution, where coastal CPCs allow foreign-flagged vessels to fish in waters in their EEZ in the IOTC Area for species managed by IOTC through a CPC-to-CPC agreement, CPCs involved in the referred agreement:

- Shall submit information concerning these agreements (paragraphs 3a, b, c, d, e, f, g),
