4. Resolution 14/04 Concerning the IOTC record of vessels authorised to operate in the IOTC area of competence a^{a}

Thailand already submitted the list of official authorised vessels and it is updated in the IOTC website. The infromation concerning these ATF.

5. Resolution 14/05 Concerning a record of licensed foreign vessels fishing for IOTC species in the IOTC area of competence and access agreement information a^{a}

Not applicatble.

According to the Act Governing the Right to Fish in Thai Water, 1939, foreign vessels are not allowed to fishing in Thai Water.

 Resolution 14/06 On establishing a programme for transhipment by large-scale fishing vessels ^a Not Aplicable.

The at sea transhipment occrued in 2013.

Referencing the official letter to IOTC secretariat on 14th May, (B.E. 2557) 2014, Thailand had submitted the report of Investigation on the Possible Infraction of Thai Tuna Longliners during At-Sea Transhipment in 2013. The transhipment had been inspected by the deployed





regional observer. The report addressed that the transhipment at sea have been implemented in accordance to the IOTC. Regarding this, the Thai authorized fishing vessels have been informed, by the DOF, the IOTC authorized carrier vessel list.

Part B. Describe the actions taken, under national legislation, to implement conservation and management measures adopted by the Commission in previous Sessions, and which have not been reported previously.

- Thailand seeks assistance on capacity building for its fishery officers to enable to complete the task stipulated in Resolution 10/04 on a regional observer scheme.

- FAO has financially and technically supported Thailand on the Pilot Port Model Project with a view to implementing Port State Measure and to learning difficulties Thailand may experience when it engages in implementation of Port State Measure Agreement and Resolution 10/11.

-Existing out-of-date Fisheries law had been revised to accommodate new obligation s such as control of its fishing operation in areas under national jurisdiction of foreign countries and in the high seasand port state measures. A new Chapter on overseas fisheries of Thai fishing vessels beyond national jurisdiction and their management is established.

- Thailand has implemented regulation regarding traceability and catch certification for fish and fishery products exported to the EU markets.

-Thailand, by support of FAO, held the Workshop on National Ecolebel for Marine Capture Fisheries during 12nd-15th January, 2015, Bangkok

• Recommendation 05/07 Concerning a management standard for the tuna fishing vessels

The CPC flag states which issues licenses to their AFVs should report annually to the Commission all measures taken to meet the minimum management standards when they issue fishing licenses to their "authorised fishing vessels".

Fishing Operation of its AFVs is managed in compliance with the Thai Fisheries Act, 1947, its' Decrees and related Regulations. The renewal of the vessel authorization have been submitted to the IOTC. These authorized fishing vessel have been monitored through VMS. Their fishing logbook have been submitted to the Department of Fisheries in regular manner. Apart for the purpose of monitor and investigation, the information derived from their logbooks are used for the scientific purpose.

• Resolution 10/06 On Reducing the Incidental Bycatch of Seabirds in Longline Fisheries

CPCs shall provide to the Commission, as part of their annual reports, information on how they are implementing this measure and all available information on interactions with seabirds, including bycatch by fishing vessels carrying their flag or authorised to fish by them. This is to include details of species where available to enable the Scientific Committee to annually estimate seabird mortality in all fisheries within the IOTC Area of Competence.

With highly concern in reducing the incidental bycatch of seabirds in longline fisheries, Thai tuna longliner operate their fishing with the bird scaring lines.

• Resolution 10/10 Concerning market related measures





For CPCs that import tuna and tuna-like fish products, or in whose ports those products are landed or transhipped, should report, a range of information (e.g. information on vessels / owners, product data (species, weight), point of export) annually. [A template report exists].

Resolution 11/04 On a Regional observer scheme

CPCs shall provide to the Executive Secretary and the Scientific Committee annually a report of the number of vessels monitored and the coverage achieved by gear type in accordance with the provisions of this Resolution.

• Resolution 12/04 On marine turtles

CPCs shall report to the Commission, in accordance with Article X of the IOTC Agreement, their progress of implementation of the FAO Guidelines and this Resolution.

According to the Thai Fisheries Act, 1947, the exploitation of marine turtles is prohibited. The article 32(7) of the Act addressed that no person shall absolutely catch, trap, injure or kill all kinds of turtles and tortoises. If any turtle or tortoise has been stuck with or by any fishing gears of fishing appliance, it must be freed into the sea immediately. The Act also addressed that, no person shall, absolutely at any beach, collect eggs of sea turtle and tortoise.

• Resolution 14/06 On establishing a programme for transhipment by large-scale fishing vessels





Each flag CPC of the LSTV shall include in its annual report each year to IOTC the details on the transhipments in ports by its vessels (Name of LSTV, IOTC Number, name of carrier vessel, species and quantity transhipped, date and location of transhipment). [A template report exists].
