<u>Feedback to Kenya on the level of implementation of IOTC Conservation and</u> Management Measures identified by the CoC11 in 2014.

Feedback: With regards to the level of compliance by Kenya to the decisions of the Commission, the Compliance Committee noted certain issues that required attention. These concerns were communicated to Kenya by the Chair of the Commission in a letter dated 5th June, 2014.

- Has not provided catch & effort data of foreign vessels (PS & LL), as required by Res. 10/02.
- Has not provided catch & effort data for coastal fisheries, as required by Res. 10/02.
- Has not provided size frequency data for the coastal fishery, as required by Res. 10/02.
- Has not implemented the prohibition on thresher sharks of all the species of the family *Alopiidae* and on oceanic whitetip sharks (*Carcharhinus longimanus*), as required by Res. 12/09 and 13/06.
- No sampling scheme for the artisanal fishery, as required by Res. 11/04.

Response: The response to the letter of the Chair of the Commission was provided by Kenya on 24 February 2015.
