Feedback to Mozambique on the level of implementation of IOTC Conservation and Management Measures identified by the CoC11 in 2014.

Feedback: With regards to the level of compliance by Mozambique to the decisions of the Commission, the Compliance Committee noted certain issues that required attention. These concerns were communicated to Mozambique by the Chair of the Commission in a letter dated 5th June, 2014.

• Has not transposed the prohibition on thresher sharks, as required by Resolution, 12/09.
• Has not transposed the prohibition on oceanic whitetip sharks, as required by Resolutions, 13/06.
• Has not transposed the provision to carry line cutters and de-hookers on board, as required by Resolution, 12/04.
• Has not transposed the seabirds mitigation measures south of 25°S into national legislation, as required by Resolution 10/06.
• Has not reported catch & effort and size frequency data for coastal fisheries and longline final and provisional, as required by Resolution 10/02.
• Has not reported catch & effort data of foreign vessels for surface fisheries and longline, as required by Resolution 10/02.
