IOTC SPECIES EXECUTIVE SUMMARIES: TARGET AUDIENCE, CONTENT AND RESOURCING

PREPARED BY: IOTC SECRETARIAT, 9 NOVEMBER 2015

PURPOSE

To request the Scientific Committee (SC) to consider and document the target audience, content and resourcing required to develop the current and/or alternative species executive summaries.

BACKGROUND

Each year, the IOTC Secretariat, based on the management advice of the species working parties, develops Draft Executive Summaries for the Scientific Committee's consideration. The content is split into two components 1) the resource stock status summary, and 2) supporting information sourced from the relevant working party report, and provided as an appendix. These are collectively called 'Executive Summaries'.

DISCUSSION

Each year, the species Executive Summaries are becoming larger with **256** pages being produced for the 2015 summaries. The original intent was for the material to be in an 'Executive Summary' style/format, however the average length is now **10.7** pages.

The SC may wish to consider examining and defining the target audience, the most appropriate content, the location (including communication formats) of the material to be used by managers and/or scientists in interpreting the management advice to the Commission, and finally, developing a budget for the preferred option/s to be provided to the Commission for its consideration in 2016.

The following is a number of non-exhaustive options for the SC to consider:

- 1) Maintain the Executive Summaries in their current format;
- 2) Expand the Executive Summaries to incorporate additional content;
- 3) To reduce the Executive Summaries to only the current Stock status summary, as currently developed by the various Working Parties, and leaving all the remainder of the supporting information in the Working Party reports, as reference material.

RECOMMENDATION/S

That the Scientific Committee **NOTE** paper IOTC–2015–SC18–12 which requested that the Scientific Committee consider and document the target audience, content and resourcing required to develop the current and alternative species executive summaries.
