## IOTC CIRCULAR

### REGARDING THE MEMBERSHIP OF SIERRA LEONE

At the 15th Session of the IOTC Compliance Committee, in May 2018, the Committee discussed the continued absence of Sierra Leone in the work of the Commission, including not fishing in the IOTC Area. In particular, the Committee noted that Sierra Leone has continually not submitted reports, not attended meetings, and has significant compliance issues. Notwithstanding this, the IOTC Standing Committee on Administration and Finance noted that Sierra Leone remained in arrears of its contributions to IOTC.

The Compliance Committee recalled the Commission had initiated a consultation with Sierra Leone, as per Article IV of the IOTC Agreement, regarding its status as a Member via letter in 2015; to which Sierra Leone did not respond.

Article IV of the IOTC Agreement states that if any Member of the Commission ceases to meet the criteria set out in Article IV, paragraphs 1 or 2 of the IOTC Agreement for two consecutive calendar years, the Commission may, after consultation with the Member concerned, determine that the Member is deemed to have withdrawn from this Agreement effective as from the date of that determination.

The Compliance Committee recommended, and the Commission endorsed, that a second letter of consultation be sent to the Ministry of Marine Resources, indicating that if a response is not received within 30 days of the date of the letter, the Commission will have deemed Sierra Leone to have withdrawn from the Agreement. I wrote to the Minister of Marine Resources in Sierra Leone on this matter on 17 August.

Please find attached the response from the Minister dated 10 September. I propose that this letter be considered by the Commission at its next session (in 2019).
