7. REVIEW OF THE IUU VESSELS LIST, THE 2018 DRAFT IUU VESSELS LIST AND THE INFORMATION SUBMITTED BY CPCs RELATING TO ILLEGAL FISHING ACTIVITIES IN THE IOTC AREA OF COMPETENCE – RES.18/03

In accordance to Resolution 18/03, if the CoC is satisfied that the documented information establishes that the vessel or vessels (included in the Draft IUU Vessels List) carried out IUU fishing activities, it shall include the vessel or vessels concerned in the Provisional IUU Vessel List. The CoC shall submit the Provisional IUU Vessel List to the Commission for its consideration.

8. UPDATE ON PROGRESS REGARDING THE PERFORMANCE REVIEW - COMPLIANCE RELATED ISSUES

The Chairperson of the WPICMM is invited to present an overview of the second meeting of the Working Party (IOTC-2019-WPICMM02-R), the Work Plan for the Working Party for the period 2019 – 2022 and the recommendations from the second meeting of the Working Party. The CoC is invited to provide comments and observations on the second WPICMM meeting, workplan and recommendations.
- ii. The European Union will be invited to present an overview of their proposal to amend Appendix V of the IOTC Rules of Procedure (IOTC-2019-S23-04) the Rules of Procedure and Terms of Reference

of the Compliance Committee. The CoC will then be invited to discuss and, as appropriate, make recommendation(s) on this matter.

At its Annual Session in 2018, the Commission reviewed document IOTC-2018-S22-04, which outlined proposed amendments to Appendix V of the Terms of Reference for the Compliance Committee. The Commission recommended the proposal be referred to the WPICMM and the CoC for further deliberations before any Commission decision on the matter.

- iii. The Twentieth Session of the Commission tasked the IOTC Secretariat with contracting an independent consultant to prepare a report identifying possible options to strengthen the IOTC VMS. A representative of Pontus Consulting Pty Ltd is invited to present an overview of document IOTC-2019-WPICMM02-VMS Study An options paper for strengthening the IOTC VMS.
- iv. CoC15 recommended that the VMS Steering Group review the report of the VMS study and provide recommendations to CoC16, including a work plan and budget and if necessary a revision of Resolution 15/03. A member of the VMS Steering Group is invited to introduce document IOTC-2019-CoC16-05a The CoC is invited to provide comments, observations and, as appropriate, make recommendation(s) on this document.
- v. The Chair will invite Australia to introduce document IOTC-2019-CoC16–05b, which sets out the proposed terms of reference (TORs) for an intersessional Working Group to progress consideration and development of an IOTC vessel monitoring system. The CoC will then be invited to discuss and, as appropriate, make recommendation(s) on this matter.
