### SHARKPROJECT International e.V.: Application for Observer Status to IOTC Meetings

Dear Ms Imende Ugandi, Dear Secretary of the Commission,

SHARKPROJECT International e.V. is an internationally active environmental NGO based in Germany. We are registered as a charity and our mission is the protection of our ocean for this and future generations, with a specific focus on shark conservation and the protection of biodiversity, with sharks being the top predators and therefore absolutely vital for healthy marine ecosystems.

Fishing provides an important source of protein for millions of people on our planet and seafood is essential for the livelihoods of many more people, especially in developing countries. Therefore, a sustainable use of marine resources and effective conservation of the biodiversity of marine ecosystems are challenging but mandatory tasks mankind must achieve.

However, today more than a third of all commercially fished species are already overfished and we are at risk of loosing more than 30% of all known species of sharks and rays, and more than a third of all marine mammals and of the reef building corals - and all of this within the next decades because of the impacts of commercial fishing over the last 50 years.

Many rays and large pelagic sharks are already categorized as threatened by the IUCN's Red List and a growing number of species has been categorised as critically endangered or endangered while the majority of species is actually still "data deficient". And although a growing number of species has been included into the Annexes of CMS and CITES for better protection this has so far only triggered some improvements for a few of these species and only in a few regions but has so far not been effective to improve overall shark abundance in most areas, including the Indian Ocean.

Therefore, SHARKPOJECT has engaged in assessments of sustainable fisheries since 2016 and has provided input and recommendations to many assessments on how to improve fisheries' sustainability with regard to ecosystem impacts and bycatch rates, with sharks obviously being our main but not our only focus and concern. As part of our engagement we have also been involved in the assessment of the impact of dFAD associated tuna fishing of purse seine fleets and their impact on Carcharhinus falciformis and Carcharhinus longimanus, as well as on vulnerable ecosystems. And we will continue working on these topics as more tuna fisheries are in the process of
