PROPOSAL TO CHANGE THE DETAILS OF A VESSEL LISTED ON THE IOTC IUU VESSELS LIST

In accordance with paragraph 30 of IOTC Resolution 18/03, the European Union has submitted new information pertaining to a vessel listed in the IOTC List of Illegal, Unreported and Unregulated (IUU) vessels.

Subject: Transmission of information under paragraph 30 of Resolution 18/03

Dear Dr. O'Brien,

As part of its efforts in fighting illegal, unreported and unregulated (IUU) fishing in the Indian Ocean region, the Directorate-General for Maritime Affairs and Fisheries of the European Commission is working in close cooperation with EUNAVFOR ATALANTA whose mandate includes contributing to the monitoring of fishing activities off the coast of Somalia.

Since February 2016, our Directorate-General has been providing the Secretariat with the data gathered by EUNAVFOR units off the coast of Somalia for further transmission to the relevant States.

This data, and further investigation by our services, also made the inclusion of five vessels in the IOTC IUU Vessel List possible in May 2018.

Since then, and as per our obligations under paragraph 30 of Resolution 18/03 on establishing a list of vessels presumed to have carried out IUU fishing in the IOTC area of competence, we regularly transmitted to you information on these vessels.

Based on new data received from with EUNAVFOR ATALANTA and further analysis by our services, I am herewith pleased to send you information on one of these vessels, namely the one listed in the IOTC IUU Vessel List under the name of AL WESAM 4, indicating that she may have changed vessels' details.

As per the legal instrument mentioned above, I would be grateful if you could communicate this information to all CPCs and seek to verify it in order to update the relevant details in the IOTC IUU Vessel List and re-publicise it.

Rest assured that our services remain at your disposal should you have any questions concerning this matter.

Information on the vessel AL WESAM 4 (poss. MARWAN 1)

In the context of the implementation of Council Regulation (EC) No. 1005/2008 establishing a system to prevent, deter and eliminate illegal, unreported and unregulated (IUU) fishing and thanks to close cooperation with EUNAVFOR ATALANTA, the services of the European Commission collected suitably documented information on what could be a vessel listed on the IOTC IUU Vessel List.

Paragraph 30 of Resolution 18/03 provides that 'a CPC with new or changed information for vessels on the IUU Vessel List in relation to the details in paragraphs 1 to 8 of Annex II shall [...] transmit such information to the IOTC Executive Secretary'.

This paper contains the suitably documented information collected to be transmitted to the Executive Secretary.

The services of the European Commission note that further information on this vessel is available in Circular 2018-36 ('Communication from Thailand regarding the rejection of a consignment of fish caught by four vessels listed in the IOTC IUU Vessels List') and has not been reflected in the IOTC IUU Vessel List (source: https://www.iotc.org/documents/communication-thailand-regarding-rejection-consignment-fish-caught-four-vessels-listed (accessed on 25/11/2019)).

Suitably documented information collected

On 17th July and 28th August 2019, a vessel identified under the name of 'MARWAN 1' was sighted by EUNAVFOR units off the coast of Somalia. The following information was reported to the services of the European Commission.

This information was accompanied by two photographs (cf. evidence A). The vessel could also have been sighted on 22nd August 2019 (1702Z) at the following location: 1130N, 4952E. However, the photograph, taken at night, does not allow for her clear and unambiguous identification although the structural features of the photographed vessel match with those depicted in the two photographs mentioned above.

As part of the regular transmission of sightings to IOTC, this information, with the exception of the sighting made at night, was sent to the Secretariat of the IOTC on 22nd November 2019 for further transmission to the States concerned.

The services of the European Commission did not limit themselves to sending the information to the Secretariat of the IOTC. They conducted an in-depth analysis of the information collected.

It results from their analysis that the vessel 'MARWAN 1' sighted on 17th July and 28th August 2019 is most certainly the vessel listed in the IOTC IUU Vessel List under the name of 'AL WESAM 4' that was renamed and repainted.

The services of the European Commission drew this conclusion after having analysed the photographs taken on the two dates above mentioned and photographs previously taken of the 'AL WESAM 4' (cf. evidence B). In order to reasonably exclude the possibility of the vessel 'MARWAN 1' to be another vessel, the services of the European Commission also analysed the photographs against those of all the other similar vessels known to be operating or to have been operating off the coast of Somalia.

On 20th November 2019, the services of the European Commission was informed that the vessel 'MARWAN 1' had been sighted again by EUNAVFOR units off the coast of Somalia on 5th and 13th November 2019 (cf. evidence C). These latter sightings will be included in the next regular transmission of sightings to IOTC together with the other sightings made during the fourth quarter of 2019.

The imagery collected was analysed as a matter of priority. <u>It corroborates the findings presented in this paper</u>.

The photographs made also depict the vessel <u>displaying the city of Bosaso (Somalia)</u> as home port suggesting that she is flying the flag of Somalia.

In the course of their verifications aiming at clarifying the identity of the vessel 'MARWAN 1', the services of the European Commission found several recent press reports referring to a situation involving a fishing vessel bearing the same name of 'MARWAN 1'. These press reports, accessible below, and this paper are most certainly referring to the same vessel.

It is noted that these press reports mention that <u>the registered owner of the vessel 'MARWAN 1' could be a legal person named 'SOMLINK FISHERIES INVESTMENT'</u>.

In this context, the services of the European Commission look forward to the contribution of Kenya and Somalia to the verifications that will be initiated by the Executive Secretary under paragraph 30 of Resolution 18/03.
