



## REPORT ON THE IOTC BIGEYE TUNA STATISTICAL DOCUMENT RECORD

PREPARED BY THE IOTC SECRETARIAT

This document summarises the information received in accordance with IOTC's Bigeye Tuna Statistical **Document Programme (Resolution 01/06), in particular for the period 2003 to the first** semester of 2009.

## Submission of data

Paragraph 5. The Contracting Parties which import bigeye tuna shall report the data collected by the Programme to the Secretary each year by April 1 for the period of July 1 - December 31 of the preceding year and October 1 for the period of January 1 - June 30 of the current year, which shall be circulated to all the Contracting Parties by the Secretary.

An overview of the level of reporting associated with the bigeye tuna statistical programme since the programmes implementation is given in Table 1.

With respect to submissions received for the year 2008, Belize has provided information for the first semester. Information for the whole year has been received from China, the European Union, Japan, Korea and Thailand. With respect to the first semester of 2009, information has been received from China, the European Union, Japan and Korea. The quantities and sources of the bigeye tuna imported by CPCs are given in Tables 2 and 3.

Paragraph 10. The Secretary shall maintain and update information specified in paragraphs 3 and 9 (samples of forms) and provide it to all the Contracting Parties, and promptly circulate any changes.

A dedicated database to input all data reported for Resolution 01/06 is maintained by the Secretariat. Updates are disseminated whenever new information is received.

All correspondence related with the implementation of the IOTC Statistical Document and Re-export Certificate Program is also entered in the database.

Paragraph 11. The Commission shall request the non-Contracting Parties which import bigeye tuna to cooperate with implementation of the Programme and to provide to the Commission data obtained from such implementation.

No information has been received from non-Contracting Parties to-date.
