## Resolution 09/03. On establishing a list of vessels presumed to have carried out illegal, unregulated and unreported fishing in the IOTC area.

I wrote to you on 10 January 2010 on behalf of the British Indian Ocean Territory (BIOT) Administration with details of five vessels flagged to Sri Lanka carrying out IUU fishing activities in the IOTC Area, specifically within the BIOT Fisheries Conservation Management Zone during 2009. By the end of 2009 we had recorded 50 incidents involving Sri Lankan Vessels since 2002 – a significant milestone. Since the end of 2009, two further vessels have been arrested. A table of all the incidents to the end of 2009 in the waters surrounding BIOT, involving vessels registered to Sri Lanka, can be found at Annex A. I would appreciate you bringing this information to the attention of the Compliance Committee for discussion in Busan next month.

At the current time I have not compiled all the details necessary for a submission under Resolution 09/03 for the two vessels that have been arrested during 2010 but I will do so in due course.

Illegal fishing by vessels from Sri Lanka poses one of the most significant threats, risks and uncertainties to the ecosystem in the waters surrounding BIOT. Whilst the BIOT Administration utilises a range of measures to protect its fisheries, including the deployment of a fisheries protection vessel that has arrested several fishing vessels over the past 12 months, the problem continues. The UK Government on behalf of the BIOT Administration has made, and continues to make, representation to the Government of Sri Lanka but the number of vessels entering the waters surrounding BIOT shows no sign of decline.

We would be most interested to discuss this in the Compliance committee and to explore any further actions that could be taken to prevent this continuing IUU threat.
