Dear Sir.

As a response of the novel coronavirus disease 2019 (COVID-19) pandemic, the Government of the Republic of Indonesia has declared an emergency situation through the Issuance of the Presidential Decree Number 11 of 2020 on the Declaration of Coronavirus Disease 2019 as Public Health Emergency. As a follow up, Indonesia has taken a national policy to reallocate the state budget to support aforementioned declaration, particularly to address the impacts within the community. This has reduced the budget allocation for Indonesia participation in regional and international fora until the end of 2020.

Therefore, we are regretfully withdrawing as the host of 24° Session of the Indian Ocean Tuna Commission, which is supposed to be held in November 2020 in Ball, Indonesia. It was a difficult decision to be made since we have been preparing the arrangement for this event for a long time and it may affect the IOTC budget plan for 2020.

Lastly, we would also like to take this opportunity to express our solidarity with Member States who are fighting the COVID-19 pandemic and our sincere condolences for their loss. Hopefully, we could strive together in our efforts to fight against the disease in the spirit of good cooperation.
