# INVITATION TO THE 6<sup>TH</sup> MEETING OF THE TECHNICAL COMMITTEE ON ALLOCATION CRITERIA 15-16 SEPTEMBER 2020

Earlier this year, IOTC Circular 2020-10 announced the postponement of the TCAC06 due to the COVID-19 pandemic. Following consultations between the Chair of the TCAC and Members, it has been decided that the TCAC will meet on 15-16 September.

This 2-day meeting will be convened by video-conference (Zoom) for 2 hours each day.
