CHANGES IN THE DATES OF THE MEETINGS OF THE WORKING PARTY ON METHODS & THE WORKING PARTY ON TROPICAL TUNA

Following consultations between the IOTC Scientific Committee Chair and the respective Chairs of the Working Party on Methods (WPM) and Working Party on Tropical Tunas (WPTT) a decision has been taken to slightly modify the dates of the WPM11 and the WPTT22. The changes are possible because there is no travel involved (due to the COVID-19 pandemic) and will mean that the meetings are better aligned to a normal working week.

Working Party on Methods: 14-15 October

30 September	Submission of full documents.

Working Party on Tropical Tuna: 19-23 October	
19 September	Deadline for Submission of document titles.
5 October	Submission of full documents.
19 – 23 October	Working Party on Tropical Tunas by video-conference.
