COMMENCEMENT OF PRE-MEETING DISCUSSIONS ON S24 AGENDA ITEMS

Due to the COVID-19 pandemic, the 24th Session of the Indian Ocean Commission will be held by video-conference, from 2 to 6 November 2020.

The execution of all agenda items will be greatly assisted if CPCs consider the documents well before the meeting and, if necessary, reach out (in advance of the meeting) to myself, the Secretariat, the Chairpersons of the subsidiary bodies, or other delegations regarding any matters they might want to raise and or discuss. This pre-meeting consideration of agenda items is expected to reduce meeting time, and moreover, help me identify important matters ahead of time and plan for those items of greater substance or complexity.

The pre-meeting discussion phase will conclude on Friday 23 October

This approach mimics the in-person meeting process where only the HOD speaks in plenary; and it also reduces the likelihood of receiving unofficial interventions (comments).

The proposed role of delegation members in this approach is for them to read and consider the meeting documents and for HODs to collate and distil the inputs from their delegations before entering them officially into the document. While, the Secretariat wants to avoid overcrowding the meeting platform, limited additional links for other essential individuals in credentialled delegations will be made available.
