CALENDAR OF IOTC MEETINGS IN 2022

The IOTC will hold the below listed meetings in 2022. Further information, including agendas and other documents, will be made available by the IOTC Secretariat via email, Circulars and the IOTC website (<u>Click here</u>).

<u>NOTE</u>: Given that the COVID-19 pandemic continues to disrupt travel and face-to-face meetings, and because there have been no offers to host any meetings in 2022, all meetings will be held by videoconference unless otherwise advised.

I am mindful that the TCAC indicated that TCAC10 should be a face-to-face meeting; however, given the outbreaks of the Delta and Omicron covid variants show no clears signs of abatement, I must advise that a face-to-face meeting for TCAC10 meeting as soon as March is not feasible. However, planning is underway for, at least, a hydrid face-to-face meeting of the Commission (and perhaps the associated meetings) in May (in Seychelles) — the Secretariat will keep you advised on this.

Meeting participation fund (for developing IOTC Contracting Parties Members only)

Videoconference meetings are not supported by the IOTC Meeting Participation Fund (MPF). If in-person meetings begin to be held, information of the MPF will be disseminated.

Credentials
