





Summary report on assessment criteria for the Compliance Report for CoC19

PREPARED BY: IOTC SECRETARIAT¹, 25 JANUARY 2022

PURPOSE

To encourage participants at the Working Party on the Implementation of Conservation and Management Measures (WPICMM) to review the assessment criteria to be used to compile the Compliance Report of CPCs, for CoC19.

BACKGROUND

At the 12th Session of the IOTC Compliance Committee, the following recommendation was made:

The CoC **RECOMMENDED** that the IOTC Secretariat provide CPCs with the assessment criteria to understand the process of how the Compliance Reports are compiled, including information on the year being assessed for each requirement (*Paragraph 47*, *IOTC–2015–CoC12–R[E]*, 62 pp).

DISCUSSION

Following the recommendation of the Compliance Committee, the IOTC Secretariat is pleased to provide document IOTC-2022-WPICMM05-06 Add1 [English], the assessment criteria to be used for the compilation of the Compliance Reports for the 2022 meeting. We would like to invite the WPCIMM05 to provide comments/observations on the assessment criteria.

We wish to bring to the attention of WPICMM05 that:

- Three reporting requirements have been introduced in the Compliance Report which relates to Resolutions adopted in 2017 and 2021, but were not being assessed previously, as indicated to the IOTC Secretariat, or were not included in the Compliance Report of the last CoC. These three requirements are highlighted in GREEN below
- Ten reporting requirements have been introduced in the Compliance Report which relates to Resolutions objected in 2017 by Pakistan (PAK), 2018 by India (IND) and 2021 by Oman (OMN), Indonesia (IDN), Iran (IRN), Madagascar (MDG), Somalia (SOM). These requirements are highlighted in GREY below.
- One reporting requirement have been introduced in the Compliance Report which relates the Resolution 21/02
 adopted in 2021, but was not reported previously to the WPICMM. That requirement is highlighted in BLUE
 below.

RECOMMENDATIONS

That the WPICMM:

- 1) **NOTE** documents IOTC-2022-WPICMM05-06, IOTC-2022-WPICMM05-06 Add1, which describes the new assessment criteria added to the 2022 Compliance Report, and IOTC-2022-WPICMM05-06 Add2, template of the Compliance Report for CoC19.
- 2) **FINALISE AND ENDORSE** the assessment criteria and the template of the Compliance Report, for the compliance assessment process in 2022 (CoC19).
- 3) **AGREE** that the IOTC Secretariat compile the Compliance Reports with the assessment criteria endorsed by the WPICMM05.
