Follow-up actions of COC 18 - Sri Lanka
Reference: Paragraph 85 of IOTC-2021-CoC18R

On the request of COC 18, Sri Lanka would like to provide the progress of the measures taken to prevent occurrence of IUU fishing using the multiday fishing vessels flag to Sri Lanka.

(1) Installation of VMS to all Multiday Vessels

Sri Lanka installed VMS to all authorized vessels in 2015, in compliance with the IOTC Resolution 06/03 and all vessels are being monitored in the land based monitoring center. In the meantime Regulation on Mandatory VMS onboard published in 2015, regulating all conditions given in the resolution 06/03.

Since non-authorized Sri Lanka vessels tend to enter high seas and other states waters Sri Lanka decided to install VMS to all multiday boats because they have the capacity to go beyond the EEZ. Therefore VMS are being installed to all multiday boats of Sri Lanka enabling those vessels to be monitored. The project implementation was delayed due to the Covid 19 pandemic and was able to receive the first batch of VMS transponders in September 2021. The total number of VMS to be installed under this project is 4200 numbers. The regulation is being amended making the VMS on board of all multiday fishing boats of Sri Lanka. The progress of VMS installation is as follows.

(2) **Enforcement of law for owners and masters of fishing vessels**

Legal actions are being taken against the all owners and the skippers of the vessels those reported with adequate and proven evidence on IUU fishing activities, under the provisions of existing legislation. In the meantime the legislation is being further strengthened, severing the penalties to the skipper and the crew reported onboard at the time of offence and the draft is pending at the Attorney Generals Department. However DFAR noted that the repeated offences have been reduced due to the legal actions taken (seizure of the vessel, illegal fish catch, suspension of operation license, Skipper license and imposing of administrative Monetary penalty/ the penalty imposed after prosecution at the Courts and detaining of the vessel until VMS installation etc.
