PROGRESS ON REQUESTS FOR ACTION MADE BY THE COMMISSION IN 2021

PREPARED BY: SECRETARIAT

PURPOSE

To provide the Commission with an opportunity to consider the progress made during the inter-sessional period on its requests for action made to the Secretariat during the 25th Session in 2021.

BACKGROUND

In 2021, the Commission made 5 specific requests for action that involved the Secretariat. To-date 4 of those requests have been completed and 1 is ongoing. The requests are listed below.

In accordance with Rule IX.1 of the IOTC Rules of Procedure there is a standing requirement for the Chairperson, each year, to send a letter to all non-contracting parties known to be fishing for IOTC species urging them to become a CPC. In 2021, letters were sent to 10 non-member coastal states.

Regarding requests from other bodies that were endorsed by the Commission in 2021:

- 5 requests for action were from the Standing Committee on Administration and Finance 4 have been completed and 1 is ongoing (IOTC-2022-SCAF19-02).
- 22 requests for action were from the Compliance Committee 13 have been completed, 8 are ongoing and 1 is pending (IOTC-2022-CoC19-09).

RECOMMENDATION/S

That the Commission:

1) **NOTE** paper IOTC–2022–S26–02 which provided the Commission with information on the progress made during the inter-sessional period on the requests for action made at its 25th Session in 2021.

2) **CONSIDER** whether any of the requests for action need further instructions or guidance.
