IOTC MID-TERM FINANCIAL REPORT FOR THE YEAR 2022

PREPARED BY: SECRETARIAT

PURPOSE

1. The IOTC Financial Regulations (2019) call for a mid-term review of IOTC finances to be prepared by the Secretariat and considered by SCAF and the Commission.

STATUS OF CONTRIBUTIONS TO THE AUTONOMOUS BUDGET IN 2022

As of 30 April 2022, around 66% of the 2022 budget has been received from Members

- 2. The total of contributions requested from Contracting Parties for the 2022 budget was (US)\$4,071,765.
- 3. As of 30 April 2022, a total of \$2,682,508 has been received. Note however, this amount of contributions also includes some outstanding contributions due from years prior to 2022.
- 4. Details on the status of contributions are available in Appendix 1.

EXPENDITURES FOR THE FIRST 4 MONTHS OF 2022

As of 30 April 2022, around 42% of the 2022 budget has been spent.

- 5. The total budget for 2022 is \$4,071,765 and as of 30 April the Commission has spent (actuals) \$1,719,444 (42% see Table 1).
- 6. The staff-related budgets (totaling \$2,598,537) are on course to be fully spent although there could be differences at year-end due to USD-SCR exchange rate fluctuations for local salaries and unforeseen post adjustment changes.
- Operations-related budgets are also on course with a total of \$727,765 spent out of a budget of \$1,293,200 (56%). However, some lines such as travel are expected to be underspent due to the impact of the pandemic. Note that the operations expenditure figures in the table include "hard commitments" made to contractual agreements such as purchase orders and contracts.

TRANSFER OF APPROPRIATIONS BETWEEN BUDGET SUB ITEMS

In accordance with the Final Regulations (2019), the Executive Secretary may authorize the transfer of up to [15] percent of appropriations between sub-items as specified in Article III.5 of this Regulation upon approval from the Chairperson of the Commission until a mid-term review.

- Due to the pandemic and lack of offers to host IOTC meetings, S26 and its associated meetings and TCAC10 are being held in Seychelles at the Commission's expense. Because of this, the 2022 meetings budget (\$146,094) has already been fully spent.
- 9. The Secretariat proposes to hold all working party meetings in 2022 by videoconference; however, if the Commission requests TCAC11 and SC25 to be held in hybrid format, then an estimated \$100,000 extra may be required in the Meetings budget line. Should the Meetings budget line require additional funds in 2022, it is proposed that these funds will be first taken from savings in other budget lines, then, only if required, from the Working Capital Fund.

MEETING PARTICIPATION FUND

- As of 30 April 2022, a total of \$112,867 has been spent under the Meeting Participation Fund. Note, the 2022 MPF budget (of \$25,000) was a top-up budget, as there were considerable savings in the MPF in 2021 due to the cessation of travel because of the pandemic.
- 11. In accordance with Rule XVI (5) of the IOTC Rules of Procedure, the MPF "will be allocated in such a way that no more than 25% of the expenditures of the Fund in one year is used to fund attendance to non-scientific meetings." Given that in-person/hybrid meetings are currently only planned for only one scientific meeting in 2022, it is proposed that this rule be waived for 2022, allowing maximum participation from the MPF to the other hybrid meetings.

OTHER FINANCIAL ELEMENTS

IOTC is managing a range of extra-budgetary funds in 2022

- 12. The Secretariat will conclude (i.e no funds being received in 2022) a multi-year project funded by the European Union (DG Maritime Affairs and Fisheries). This project supported technical assistance to developing countries to improve implementation of at sea observer scheme, data collection and the work of the both the Scientific Committee and Compliance Committee.
- 13. Later in 2022, the Secretariat is expected to receive extra-budgetary funds of around \$800,000 from the European Union (DG Maritime Affairs and Fisheries) for a multi-year project to support a range of scientific and compliance related activities that have been prioritized by the Commission through its technical bodies.
- 14. The Regional Observer Programme (ROP) has received a total of \$590,040 so far in 2022 from the fleets participating in the programme. Surplus funds are also available from 2021 to keep the ROP functioning at the current level of deployments.

SUGGESTED ACTION BY THE STANDING COMMITTEE ON ADMINISTRATION AND FINANCE

That the SCAF:

- a) **NOTE** the mid-term financial report for the year 2022.
- b) NOTE that an estimated \$100,000 extra may be required in the 2022 Meetings budget line if the Commission requests TCAC11 and SC25 to be held in hybrid format; and RECOMMEND that, should the Meetings budget line need additional funds in 2022, these funds will be first taken from savings in other budget lines, then, only if required, from the Working Capital Fund.
- c) **RECOMMEND** a WAIVER of Rule XVI (5) of the IOTC Rules of Procedure in 2022 to allow maximum participation in the Meeting Participation Fund.
