SubjecRegarding objection to IOTC Resolution 21/01, IOTC Yellowfin tuna allocated catch limits for 2023.

Ref: IOTC Circular no. 2022-56 Date: 31 December 2022.

In response to the subject mentioned above, Bangladesh would like to take into consideration that it has raised objection on IOTC Resolution 21/01 (Proposal M&J_Rev1), on an interim plan for rebuilding the Indian Ocean Yellowfin tuna stock in the IOTC area of competence in the last 26thCommission Meeting, held in Seychelles on 16-20 May 2022.

In this connection, as CPC, Bangladesh has submitted its written objection on IOTC Resolution 21/01, letter no. 33.00.0000.129.24.007.09 (part-1)-187, dated 31 July, 2022. Bangladesh has nominal or no reported historical catch record on Yellowfin tuna, has no Yellowfin tuna vessels and no fishing vessels fishing outside the EEZ of Bangladesh within the IOTC area of competence. Therefore, currently no fishing vessel is fit for this resolution. As a result, we would like to seek support to allow no catch limit for developing Yellowfin tuna fisheries.

In these circumstances, we would like to draw your attention that the IOTC Resolution 21/01 is not applicable for Bangladesh; therefore, no catch limit is applicable for Bangladesh in 2023.

It would be highly appreciated if the commission could circulate the letter among other CPCs.
