• Has not provided all mandatory information on vessels greater than 24m LOA, as required by Resolution 19/04.	Submitted with compliance questionnaire for vessels above 24m LOA.
 Has not provided data for catch & effort for coastal fisheries, as required by Resolution 15/02. 	Submitted, attached with the feedback letter.
• Has not provided data for size frequency for coastal fisheries, as required by Resolution 15/02.	SFA encountered difficulties to measure tuna and tuna- like species at landing sites due to limited access to the fish during unloading. Sampling programme was intensified during 2022. Data will be submitted in June 2023.
 Has not provided data for size frequency for longline fisheries, as required by Resolution 15/02. 	SFA encountered major delays in data recapture of the size frequency (previously lost due to Virus on its server). Data for 2021 was submitted in December 2022. Historical data (2016 to 2020) will be submitted in June 2023.
 Has not provided nominal catch data for sharks, as required by Resolution 15/02 	Submitted, attached with the feedback letter.
 Has not provided catch & effort data for sharks, as required by Resolution 15/02. 	Submitted, attached with the feedback letter.
• Has not provided size frequency data for sharks, as required by Resolution 15/02.	Data for the longline fleet were provided. Data for the purse seine fleet are available from Observer Programme. However, due to some technical issues with the central database, it is currently not possible to extract the data. The information will be made available when the issues are sorted.
• Has not provided information on seabirds as required by Resolution 12/06.	Submitted. Attached with the feedback letter.
• Has not provided mandatory transhipments in port report as required by Resolution 21/02.	Submitted. Attached with the feedback letter.
• Has not provided inspection reports as required by Resolution 16/11.	20 vessels were inspected throughout the year 2021, 4 PIR was submitted to the platform and 16 OLT were submitted. Due to restrictions imposed during the Covid 19 outbreak, we were unable to perform more inspections.
• Has not inspected at least 5 per cent of LAN/TRX as required by Resolution 16/11	Due to restrictions imposed during the Covid 19 outbreak, access to fishing vessels were restricted, hence we were unable to conduct the required level of inspection.
 Has not provided report of progress on implementation of FADs management plan, as required by Resolution 19/02. 	Submitted. Attached with the feedback letter.
• Has not provided report on corrective actions taken to adhere to prescribed catch levels as required by Resolution 21/01.	Submitted. Attached with the feedback letter.

 Prohibition to gaff, lift by the gill slits/spiracles, punch holes through the bodies. Obligation to release alive, implementation of live release handling procedures of mobulid rays does not cover all fisheries as required by Resolution 19/03. 	Report submitted. Attached with feedback letter. Seychelles is undertaking a comprehensive 1-year survey of the artisanal and recreational fishery to assess the occurrence of mobulids sp. Additionally the domestication of IOTC's CMMs is expected to be completed in 2023 and will provide the legal framework for the implementation of the requirements for the artisanal and subsistence fisheries.
• Has not provided data on interactions with marine turtles as required by Resolution 12/04.	Information was presented in the National Report (<i>IOTC-2022-SC25-NR22E_Seychelles</i>), under section 5.3 on Marine turtles. However, we are experiencing some technical issues with the central database, and it is currently not possible to extract the observer data. The information can be made available as soon as the technical issues are rectified.
