1. Opening of the Session.

The Chair will provide opening remarks to the 20th Session of the Compliance Committee.

2. Letters of Credentials.

The Secretariat will inform the meeting on the number of CPCs and observers who have submitted credentials to participate in CoC20.

3. Admission of Observers.

The Chair will invite the Secretariat to inform the meeting on the number of observers who have submitted credentials to participate in CoC20.

In accordance with Article VII of the IOTC Agreement on 'Observers' and Rule XIV of the IOTC Rules of Procedure on the 'Participation by observers', Observers from FAO Members and Associate Members of FAO, intergovernmental organisations, non-governmental organizations, consultants and experts may be represented and authorised to participate in the discussions of the Commission, the Committees and the other subsidiary bodies of the Commission, without voting right.

4. Adoption of the Agenda and arrangements for the Session.

The Chair will introduce the Provisional Agenda for CoC20 (IOTC-2023-CoC20–01a) that was made available in accordance with Rule IV of the Commission's Rules of Procedure (2022), the Provisional Annotated Agenda (IOTC–2023–CoC20–01b) and the List of Documents (IOTC–2023–CoC20–02).

- 5. Report of the Working Party on the Implementation of Conservation and Management Measures (WPICMM06). The Chair will invite the plenary to note document <u>IOTC-2023-CoC20-12</u>. The Chair will invite the Chair of WPICMM06 to present a summary of the report of the last meeting of the Working Party and to inform the Compliance Committee of any issues, outstanding or not, that require the attention of the Committee.
 - **5.1.** Review the list of Large-Scale Tuna Longline Vessels (LSTLVs)/carrier vessels presumed to have committed infractions against IOTC CMMs under the at-sea transshipment programme.

The Chair will invite the plenary to consider and discuss the evidence indicating possible violation of IOTC CMMs by a LSTLV, which the flag State has not provided a report of its investigation for the consideration of the WPICMM06, and recommend actions. The Chair will summarise the discussions on document IOTC-2023-CoC20-08b.

- **12.** Review of the Draft IUU Vessels List IOTC <u>Resolution 18/03</u>.

The Chair will invite the proponents for the listing of fishing vessels to the 2023 IOTC Provisional IUU Vessels List, to present their cases. The Chair will invite the plenary to provide comments, observations and, as appropriate, make recommendation(s) on a case-by-case basis. The Chair will summarise the discussions on each case.

In accordance with IOTC Resolution 18/03, if the CoC is satisfied that the documented information establishes that the vessel or vessels (included in the Draft IUU Vessels List) carried out IUU fishing activities, it shall include the vessel or vessels concerned in the Provisional IUU Vessel List. The CoC shall submit the Provisional IUU Vessel List to the Commission for its consideration.

- **13.** Review of recommendations requiring intersessional actions, from CoC19.
 - i. The Chair will invite the Secretariat to introduce document <u>IOTC-2023-CoC20-14</u> on the Implementation of Recommendations from CoC19. The Chair will invite the plenary to provide comments, observations and, as appropriate, make recommendation(s) on this document. The Chair will summarise the discussions on document IOTC-2023-CoC20-14.
 - *ii.* The Chair will invite the Secretariat to introduce document <u>IOTC–2023–CoC20–06</u> on Capacity of fishing vessels in the IOTC Record of Authorised Vessels. The Chair will invite the plenary to provide comments, observations and, as appropriate, make recommendation(s) on this document. The Chair will summarise the discussions on document IOTC–2023–CoC20–06.
