Re. IOTC observer status

Dear Madam.

BLOOM is a non-profit organization founded in 2005 that works to preserve the marine environment and species from unnecessary destruction, and to increase social benefits in the fishing sector. BLOOM wages awareness and advocacy campaigns to accelerate the adoption of concrete solutions for the ocean, humans, and the climate. BLOOM carries out scientific research projects, independent studies and evaluations that highlight crucial and unaddressed issues such as the financing mechanisms of the fishing sector. BLOOM's actions are meant for the general public as well as policymakers and economic stakeholders.

As part of our research and advocacy campaigns, we have a keen interest in tropical tuna fisheries, especially those that occur within the IOTC area of competence. Over the past few months, we have published several reports covering a case of illegal secondment between the French administration and the European tuna lobby,¹ the dynamics in IOTC delegations,² the lack of enforcement of EU rules by European fleets,³ the role that the EU has in the continuous overexploitation of tuna populations in the Indian Ocean,⁴ and the out-of-control 'technological creep' of the FADs used by the European fleets.^{5,6}

Having worked on these fisheries for several years, we are a well identified actor and benefit from a solid network of collaborators in the world, many of whom already take part in IOTC matters.

As such, we are hereby applying for IOTC observer status, as we believe that both BLOOM and the IOTC as a whole would benefit from it.
