(Oceana) is the largest international advocacy organization dedicated solely to ocean conservation with a mission to protect and restore the world's oceans. We are overseen by a multinational board of directors experienced in marine science, governance, business and philanthropy, with a global headquarters in Washington, DC, USA, and offices in twelve fishing nations.
