PROGRESS ON REQUESTS FOR ACTION MADE BY THE COMMISSION IN 2023

PREPARED BY: SECRETARIAT

PURPOSE

To provide the Commission with an opportunity to consider the progress made during the inter-sessional period on its requests for action made to the Secretariat during the 27th Session in 2023.

BACKGROUND

In 2023, the Commission made 11 requests for action. To-date 8 of those requests have been completed and 2 are ongoing and 1 has not been completed. The requests are listed below.

In accordance with Rule IX.1 of the IOTC Rules of Procedure there is a standing requirement for the Chairperson, each year, to send a letter to all non-contracting parties known to be fishing for IOTC species urging them to become a CPC. In 2024, letters were sent to 10 non-member coastal states.

Regarding requests from other bodies that were endorsed by the Commission in 2023:

- 6 requests for action were from the Standing Committee on Administration and Finance 4 have been completed and 2 are ongoing (IOTC-2024-SCAF21-03).
- 8 requests for action were from the Compliance Committee 6 have been completed, 2 are ongoing (IOTC-2024-CoC21-09).
