1. Opening of the Session.

The Chair will provide opening remarks to the 22nd Session of the Compliance Committee.

2. Letters of Credentials.

The Chair will invite the Secretariat to inform the meeting on the number of CPCs and observers who have submitted credentials to participate in CoC22.

3. Admission of Observers.

The Chair will invite the Secretariat to inform the meeting on the number of observers who have submitted credentials to participate in CoC22.

In accordance with Article VII of the IOTC Agreement on 'Observers' and Rule XIV of the IOTC Rules of Procedure on the 'Participation by observers', Observers from FAO Members and Associate Members of FAO, intergovernmental organisations, non-governmental organizations, consultants and experts may be represented and authorised to participate in the discussions of the Commission, the Committees and the other subsidiary bodies of the Commission, without voting right.

Cross listing - The Chair will invite the concerned flag States (Philippines and South Africa) to provide their reactions, additional information and/or clarifications. The Chair will invite the plenary to provide comments, observations and, as appropriate, make recommendation(s) on a case-by-case basis. The Chair will summarise the discussions on each case.

Removal of vessels included in the IOTC IUU vessels list - The Chair will invite the concerned flag States (India and Sri Lanka) to provide their cases, additional information and/or clarifications. The Chair will invite the plenary to provide comments, observations and, as appropriate, make recommendation(s) on a case-by-case basis. The Chair will summarise the discussions on each case.

Update information on vessels included in the IOTC IUU vessels list - The Chair will invite the concerned flag States (Iran, Sri Lanka and Panama) to provide their cases, additional information and/or clarifications. The Chair will invite the plenary to provide comments, observations and, as appropriate, make recommendation(s) on an update-by-update basis. The Chair will summarise the discussions on each update. information establishes that the vessel or vessels (included in the Draft IUU Vessels List) carried out IUU fishing activities, it shall include the vessel or vessels concerned in the Provisional IUU Vessel List. The CoC shall submit the Provisional IUU Vessel List to the Commission for its consideration.

11. Review of recommendations requiring intersessional actions, from CoC21.

The Chair will invite the Secretariat to introduce document <u>IOTC-2025-CoC22-09</u> on the Implementation of Recommendations from CoC21. The Chair will invite the plenary to provide comments, observations and, as appropriate, make recommendation(s) on this document. 12. Review of requests for the renewal of the status of Cooperating Non-Contracting Party (CNCP)- Appendix III of the IOTC Rules of Procedure.

The Chair will invite the Secretariat to inform the plenary on the requests that have been received for application or renewal for CNCP status, compliance status with the deadline to submit requests and compliance status with submission of information in order to have the CNCP status considered.

The Chair will summarise the discussions on Panama's and Liberia's requests.
