A COMMUNICATION FROM VANUATU.

Please find attached a communication from Vanuatu regarding the status of some twenty Vanuatu flagged vessels. It is noted that position reports, as of 7 November 2025, indicate that eight of the twenty vessels were sailing through the IOTC Area, possibly on route to the Atlantic Ocean. Taking into account that these vessels have not been issued, with an International Authorisation to Fish Certificate by the Competent Authority of the Republic of Vanuatu, we are bringing this information to the attention of Members and Cooperating Non-Contracting Parties.

The Ministry of Foreign Affairs, International Cooperation and External Trade of the Republic of Vanuatu presents its compliments to the Indian Ocean Tuna Commission in Seychelles, and has the honour to convey information regarding a matter of urgent importance relating to Vanuatu-flagged vessels currently under compliance investigation for suspected Illegal, Unreported and Unregulated (IUU) fishing activities.

The Ministry would like to further inform the Commission that these 20 Vanuatu flagged vessels/trawlers have not acquired the International Authorization to Fish Certificate (IATF), and are being investigated for possible breaches below. An attachment is provided to display the current position of these trawlers.

- Vanuatu's Fisheries Act No. 10 of 2014;
- International and regional obligations under Regional Fisheries Management Organization (RFMO) frameworks; and
- FAO compliance protocols.

This notification is issued as part of Vanuatu's continuing commitment to its flag State responsibilities and to the international effort to prevent, deter, and eliminate IUU fishing. The Government of Vanuatu wishes to inform the commission that this action demonstrates its determination to uphold transparency, cooperation, and accountability in fisheries governance.

The Ministry of Foreign Affairs, International Cooperation and External Trade of the Republic of Vanuatu avails itself of this opportunity to renew to the Indian Ocean Tuna Commission in Seychelles, the assurances of its highest consideration.


























