

## Review the possible violations detected under the Regional Observer Programme in 2025

PREPARED BY: IOTC SECRETARIAT<sup>1</sup>, 23 JANUARY 2026

### PURPOSE

To provide participants at the Working Party on the Implementation of Conservation and Management Measures (WPICMM) with the list of:

- Possible violations, against IOTC Conservation and Management Measures (CMMs), detected under the Regional Observer Programme (ROP) in 2025 and as recorded by observers deployed under the at-sea transshipment programme,
- Repeated possible violations in 2025,
- Repeated possible violations by LSTLVs in 2025 that have a record of possible violations in 2024.

### BACKGROUND

The component 5, sub-component 5.2, of the Work Plan of the WPICMM comprise the following activities:

5	Review of potential infractions from the ROP and PSM
5.2	Investigation or actions taken by the flag State under Regional Observer Programme (ROP) to monitor transshipment at sea (Resolution 24/05 <sup>2</sup> )
5.2.1	WPICMM to review the evidence to be presented, request further evidence from the CPCs on the list of vessels presumed to have committed infractions under ROP

### DISCUSSION

#### A) Possible infractions in 2025

The Work Plan of the WPICMM, on component 5 “Review of potential infractions from the ROP and PSM”, and more specifically, on Sub-component 5.2, makes provision for CPCs to review the list of possible violations detected under the ROP and, as appropriate, recommend actions for the Compliance Committee (CoC) on the list of vessels presumed to have committed infractions.

In line with the above, the [Sixteenth Session of the Compliance Committee \(CoC16\)](#) made the following recommendation:

[IOTC-2019-CoC16-R](#) Paragraph 31: Notwithstanding the timing of the WPICMM meeting and the deadline for responses, the CoC **RECOMMENDED** that the responses to the possible infractions be analysed by the IOTC Secretariat.

In view of the above recommendation, the IOTC Secretariat notified the list of possible violations reported up to the 31<sup>st</sup> December 2025 (Appendix I), in order to receive the results of the investigations by 15<sup>th</sup> January 2026, from the concerned fleets.

In line with the requirement of IOTC Resolution 25/05 *On establishing a programme for transshipment by large-scale fishing vessels*, this document provides a summary of the observed possible infractions against IOTC Resolutions by Large Scale Tuna Longline Vessels (LSTLVs) and carrier vessels, as recorded by observers deployed under the Programme during 2025.

Paragraph 35. The IOTC Secretariat shall, when providing CPCs with copies of all raw data, summaries and reports in accordance with paragraph 10 of Annex IV to this Resolution, also indicate evidence indicating possible violation of IOTC CMMs by LSTLVs/carrier vessels flagged to that CPC. Upon receiving such evidence, each CPC shall investigate the cases and report the results of the investigation back to the IOTC Secretariat by 15 January. The IOTC Secretariat shall inform the IOTC Compliance Committee, through WPICMM, of the list of names and flags of the LSTLVs/Carrier vessels that were involved in such possible violations as well as the response of the flag CPCs. This shall include the possible violations of LSTLVs/carrier vessels of Indonesia referred to in paragraph 29.

The summary of possible violations is presented in Table 1, and is sorted by fleet across four distinct categories: Possible violations relating to authorisation to fish (ATF), Possible violations relating to Vessel Monitoring System (VMS), Possible violations relating to fishing logbooks, and Possible violations relating to marking of fishing vessels. The category “Other types of violations”, captures other possible violations not recorded under the abovementioned four categories. Detailed information on these possible violations are available in Appendix I. The observations made by observers are in fulfilment of their assigned tasks, as specified in Resolution 25/05.

Annex IV, Paragraph 5. The observer tasks shall be as follows:

- a) On the fishing vessel intending to tranship to the carrier vessel and before the transhipment takes place, the observer shall:
  - i. check the validity of the fishing vessel’s authorisation or licence to fish tuna and tuna-like species and sharks in the IOTC area of competence;
  - ii. check and note the total quantity of catch on board, and the quantity to be transferred to the carrier vessel;
  - iii. check that the VMS is functioning and examine the logbook;
  - iv. verify whether any of the catch on board resulted from transfers from other vessels, and check documentation on such transfers;
  - v. in the case of an indication that there are any violations involving the fishing vessel, immediately report the violations to the carrier vessel’s master,
  - vi. report the results of these duties on the fishing vessel in the observers report.

In all, up to the 31<sup>st</sup> December 2025, a total of 72 possible violations were recorded (2024: 101; 2023: 127; 2022: 148), of which:

- 10 related to ATF (2024: 33; 2023: 26; 2022: 13),
- 6 related to VMS (2024: 4; 2023: 11; 2022: 3),
- 8 related to fishing logbook (2024: 13; 2023: 38; 2022: 50),
- 40 related to marking of vessels (2024: 51; 2023: 52; 2022: 81),
- 8 related to other types of violations (2024: 13; 2023: 38; 2022: 50),

These were communicated to the concerned fleets participating in the Programme, as and when the concerned deployment reports were approved by the IOTC Secretariat.

Of the total possible violations notified, 71 responses were received from the relevant fleets (Table 1). Six (6) fleets, China, Japan, Malaysia, Oman, Seychelles and Taiwan, Province of China submitted their responses by the deadline of 15<sup>th</sup> January 2026. One fleet, Korea (Republic of), has not provided its response to the reported possible infraction. The responses submitted by the six fleets are provided in meeting document [IOTC-2026-WPICMM09-05\\_Add1](#).

**B) Repeated possible infractions in 2025**

In consideration of; 1) the requirement of IOTC Resolution 25/05 *On establishing a programme for transshipment by large-scale fishing vessels*, and 2) the recommendation made by the Compliance Committee (CoC) at its 10<sup>th</sup> Session:

53. The CoC **RECOMMENDED** that the Secretariat follow, from one year to the next, the potential infringement cases identified so as to allow the CoC to identify repeated cases of infringement.

In consideration of the recommendation made by the Working Party on Implementation of Conservation and Management Measures at its 4<sup>th</sup> Session:

21. The WPICMM04 **RECOMMENDED** that the IOTC Secretariat prepare a paper on repeated possible infractions to the next WPICMM.

This document provides a summary of repeated cases of potential violations of IOTC Resolutions by large-scale tuna longline vessels (LSTLVs) and carrier vessels, as recorded by observers deployed under the at-sea Transshipment Programme during 2025.

- **Identification of possible repeated violations by LSTLVs in 2025.**

From the seven (7) fleets which have transhipped in 2025, four (5) fleets, China [1 LSTLVs 2 PI], Taiwan, Province of China [9 LSTLVs 22 PI], Malaysia [2 LSTLVs 5 PI], Oman [1 LSTLVs 4 PI] and Seychelles [1 LSTLVs 4 PI] have vessels with repeated possible violations in ROP 2025.

Repeated possible infractions of the same type, may have been reported multiple times for a particular LSTLV during the same, overlapping or consecutive deployments, prior to their communication to the respective fleet for their investigation and appropriate action.

The list of LSTLVs with repeated potential violations in 2025 is presented by category of possible infraction, and by fleet, in Appendix 1.

- **Identification of repeated possible violations by LSTLVs in 2025 that have a record of possible violations in 2024.**

Five (5) fleets, China [5 LSTLVs - 2024 10 PI, 2025 6 PI], Korea [1 LSTLV - 2024 1 PI, 2025 1 PI], Malaysia [2 LSTLVs - 2024 3 PI, 2025 3 PI], Oman [4 LSTLVs - 2024 10 PI, 2025 7 PI], and Seychelles [2 LSTLVs - 2024 2 PI, 2025 2 PI] have LSTLVs with a record of repeated possible violations in 2025 that have one or more records of possible violations in 2024.

The list of LSTLVs with repeated potential violations in 2025 and record of possible violations in 2024 is presented by category of possible infraction, and by fleet, in Appendix 1.

---

**RECOMMENDATION/S**

That the WPICMM09:

- 1) **NOTE** paper IOTC–2026–WPICMM09–05 on the review of the possible violations detected under the Regional Observer Programme in 2025, and further **NOTE** that one fleet, Korea, has not provided its response to the possible infraction,
- 2) **RECOMMEND** that Korea provide its response to the possible infraction detected in 2025 during the meeting of the WPICMM09 and by writing within 15 days after the WPICMM09 to the Secretariat, which shall be tasked to prepare a meeting document for the next Compliance Committee (CoC23) for discussion.

Possible infraction in 2025

- 3) **NOTE** that six fleets, China, Japan, Malaysia, Oman, Seychelles and Taiwan, Province of China, have provided their responses before the deadline of 15<sup>th</sup> January 2026.

Repeated possible infraction in 2025

- 4) **NOTE** that five (5) fleets, China, Taiwan, Province of China, Malaysia, Oman and Seychelles have vessels with repeated possible violations in ROP 2025.

Repeated possible infraction in 2025 with a record of possible violations in 2024

- 5) **NOTE** that five (5) fleets, China, Korea, Malaysia, Oman, and Seychelles have LSTLVs with a record of repeated possible violations in 2025 that have one or more records of possible violations in 2024.
