



## Compendium of capacity building activities - CPCs to provide information on capacity building activities that they provide and that developing CPCs can utilize

PREPARED BY: IOTC SECRETARIAT<sup>1</sup>; 23 JANUARY 2026

### PURPOSE

Component 1 of the Work Plan of the Working Party on the Implementation of Conservation and Management Measures (WPICMM) requires that CPCs provide information on capacity building activities that they provide and that developing CPCs can utilize. The Secretariat is subsequently required to compile and publish the information as a compendium of capacity building activities.

### BACKGROUND

The component 1, sub-component 1.1 of the Work Plan of the WPICMM comprises the following activities:

That the WPICMM09:

- 1) **NOTE** the meeting document IOTC-2026-WPICMM09-06, which present the contribution from CPCs,
- 2) **NOTE** that two CPCs, Japan and Kenya, are offering, respectively, three and four capacity building activities.
- 3) **NOTE** that Thailand has a) no ongoing or planned capacity-building initiatives to offer, but may offer some in the future depending on availability, b) provide its capacity building needs,
- 4) **CONSIDER** any actions to be taken on the Capacity Building Compendium and make Recommendations to the Compliance Committee CoC23.

**Subject: Response to IOTC REF: IOTC 2025-307 on the Implementation of the WPICMM Workplan – Intersessional Activities for WPICMM09**

With reference to IOTC REF: IOTC 2025-307, which requests CPCs to provide (1) information on ongoing or planned capacity-building initiatives to other CPCs, and (2) experiences, issues, and suggestions related to IOTC IT reporting systems, Thailand would like to provide the following information in response:

**1. Capacity-building initiatives of Thailand**

Thailand currently has no ongoing or planned capacity-building initiatives, nor has it allocated any budget for activities intended for other IOTC CPCs. Should such initiatives become available in the future, Thailand will submit the relevant information using the template form provided by the Secretariat.

**2. Capacity-building needs of Thailand**

Thailand wishes to express its interest in receiving training and/or technical assistance in the following areas:

2.1 Reporting under the Regional Observer Scheme (ROS): Training related to the operation, data collection, sampling, and observation activities conducted at ports or at sea.

2.2 Access and use of the e-FADs system: Training on the operation of the electronic system for authorized Fish Aggregating Devices (FADs) within the IOTC Area of Competence, including the DFADs Register, once it becomes operational.

**3. Additional comments and suggestions regarding IT reporting systems**

3.1 Observer data reporting system: Thailand would like to inquire whether IOTC has a dedicated reporting system specifically for observer data, separate from other reporting systems, to facilitate efficient monitoring and reporting of observer activities, given the large number of observer-related forms and datasets.

3.2 Training curriculum for Regional and National Observers: Thailand would like to seek clarification on the differences between the training curricula for Regional Observers and National Observers, and whether there are pathways or opportunities for enhancing the capacity of National Observers to meet the standards or qualifications equivalent to those of Regional Observers.

3.3 Limitations in the e-RAV system: It has been observed that in the e-RAV system, which registers vessels authorized to operate within the IOTC Area of Competence, the "Total Volume" field is currently limited to a maximum of 1,000 cubic meters, whereas some Thai carrier vessels have capacities exceeding this limit. Thailand would therefore like to suggest that IOTC consider revising the system to allow input values greater than 1,000 cubic meters, in order to ensure accurate and realistic reporting of vessel capacities.
