

**Request for Extension of Sri Lanka's Fleet Development Plan (FDP) from 2025 to 2030**

Dear Dr. Paul de Bruyn,

Sri Lanka initially submitted the Fleet Development Plan (FDP) for Tuna and Sward fish fishery, on 18 March 2016 and subsequently updated it on 17 September 2020 for the period 2021–2025. However, Sri Lanka has been unable to fully implement the proposed FDP for the period 2021–2025 due to severe and prolonged economic constraints that have affected the country over the past decade.

Sri Lanka has recently reviewed and amended its current Fleet Development Plan (Annex I). As part of this revision, the proposed number of gillnet longline combination vessels has been reduced, in recognition of their contribution to ecosystem impacts, including potential interactions with non-target and vulnerable species. In the meantime, fleet development is being directed towards Seasonal combinations of longline and pole-and-line fisheries. This adjustment demonstrates Sri Lanka's strong commitment to aligning its fleet development with sustainable fishing practices and ecosystem-based management principles, consistent with IOTC conservation and management measures.

Given the combined impact of economic constraints and the new sustainability-oriented amendments to the FDP, Sri Lanka extend the implementation period of the Fleet Development Plan by an additional five (05) years, from 2025 to 2030. This extension will allow Sri Lanka to achieve the revised targets while ensuring compliance with all relevant IOTC resolutions and the long-term sustainability of fisheries resources.

Sri Lanka kindly requests the Secretariat to circulate this letter to the Contracting Parties of the IOTC for their information.
