**REPORTING REQUIREMENTS**

There are 3 reporting requirements for the flag State, namely 1) to submit the templates of the fishing logbooks/or electronic screenshots and software name by 15 February 2016; 2) to submit any changes to the templates of the fishing logbooks; and 3) to submit all data collected through the logbook for each year by 30 June of the following year.

Submit templates of the logbooks/ electronic screenshots and software name, to record data in Annexes I-III to the IOTC Executive Secretary

Updated fishing logbook templates after 15 February 2016 to be submitted to the IOTC Executive Secretary

Provide all data collected through logbook for previous year on an aggregated basis to the IOTC Secretariat

**REPORTING REQUIREMENTS:
FORMAT AND CONTENT**

The minimum data recording requirements have been set in Annexes I-III of this Resolution and the logbook templates. The submission of aggregated data shall follow formats and forms templates developed by the Secretariat and Scientific Committee. The data shall be reported in accordance with the timeline of Resolution 15/02.

REPORTING REQUIREMENT 1:

SUBMIT TEMPLATES OF THE FISHING LOGBOOKS TO RECORD DATA IN ANNEXES I-III TO THE IOTC EXECUTIVE SECRETARY

IMPLEMENTATION

- How to report: The flag State CPC should address an official letter to the IOTC Executive Secretary with the logbook templates attached. Where the logbook is not in one of the two languages of the IOTC, CPCs shall provide a complete field description of the logbook in one of the two languages of the IOTC together with the submission of the sample of the logbook.
- Reporting format: Official letter with templates of logbooks.
- Where to send the information: The letter should be mailed to iotc-secretariat@fao.org

REPORTING REQUIREMENT 2:

SUBMIT THE UPDATED FISHING LOGBOOK TEMPLATE(S) TO THE IOTC EXECUTIVE SECRETARY (AFTER 15 FEBRUARY 2016)

IMPLEMENTATION

- How to report: The flag State CPC should address an official letter to the IOTC Executive Secretary with the updated fishing logbook templates attached. Where the logbook is not in one of the two languages of the IOTC, CPCs shall provide a complete field description of the logbook in one of the two languages of the IOTC together with the submission of the sample of the logbook.
- Reporting format: Official letter with updated logbook templates attached.
- Where to send the information: The letter should be mailed to iotc-secretariat@fao.org

REPORTING REQUIREMENT 3:

PROVIDE ALL DATA FOR PREVIOUS YEAR ON AN AGGREGATED BASIS TO THE IOTC SECRETARIAT

IMPLEMENTATION

- How to report: This data shall be compiled in the reporting formats developed by the Secretariat and Scientific Committee and submitted under cover of an official letter to the IOTC Secretariat and the Scientific Committee.
- Reporting format: IOTC data reporting formats and procedures.
- Where to send the information: The letter should be mailed to iotc-secretariat@fao.org

COOPERATION REQUIREMENTS

There are none in this resolution.

OBLIGATIONS OF THE INDUSTRY

The master shall complete the fishing logbook and submit the data according to the established data requirements.

OBLIGATIONS OF THE SECRETARIAT

The IOTC Executive Secretary shall publish the sample of the logbook and the field description on the IOTC website, <http://www.iotc.org/compliance/authorizations-templates-samples>

OBLIGATIONS OF THE COMMISSION & BODIES

The Commission shall consider development of a special programme to facilitate the implementation of this Resolution by developing CPCs.
