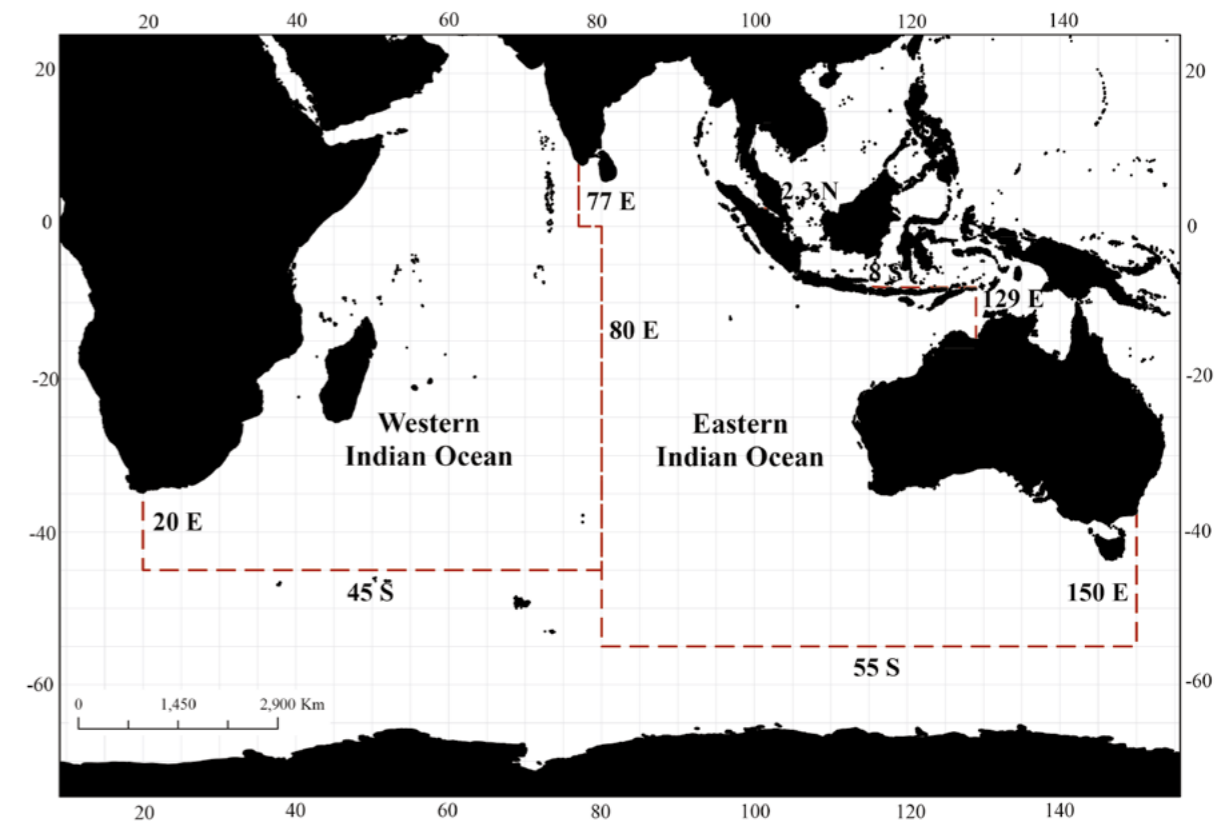


Figure 1: Map of the IOTC Area of Competence (source: IOTC)
