# **e-DFAD: state of play**

## **Current state of the e-DFAD register**

- **"Pilot" covered:**
  - User and reference data management
  - Interactive and Bulk DFAD Registration and Buoy Activation/Deactivation
  - Notification of Deactivation in a Coastal State's EEZ
  - Notification of Activation over quota for a given vessel

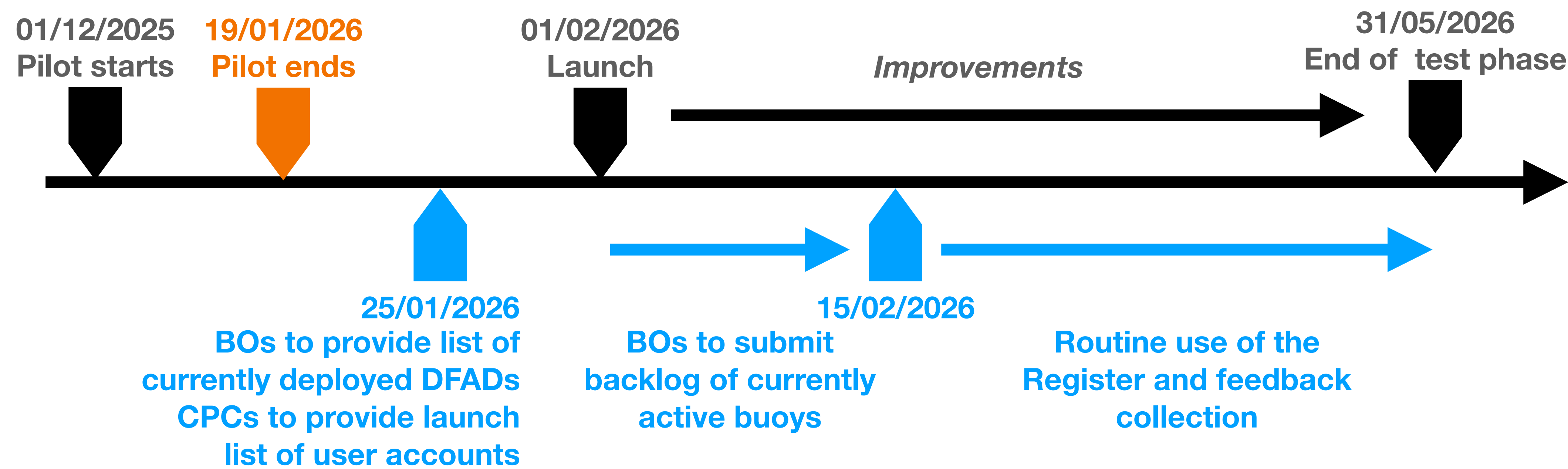
# **e-DFAD: state of play**

## **Pilot feedback**

- 6 Buoy Owner/Companies participated
- No official feedback was received so far
- Now is the time if you have comments/suggestions

# e-DFAD: timeline

## Backlog of already active buoys

- By 25/01/2026, BOs to provide list of currently deployed DFADs, so the dev team can pre-register them in the app
- After launch, BOs to submit backlog of Activations within a 15 days period using the pre-registered DFADs (allowing retroactive activations)
- Any registration/operation happening after launch to be entirely handled by BOs in the app
- Detailed instructions will be provided closer to launch

# **e-DFAD: timeline**

## **Mandatory test period**

- As per Commission agreement, a mandatory test period will last from launch until 31/05
- It will allow a progressive ramp up and adjustments to the app as necessary
- Collection of feedback to happen during the whole phase
- After the end of this phase, a report will be produced, incorporating feedback received
- On 01/06/2026, the Register will fully enter production

## **Improvements since Pilot started**

- Multi-manager accounts for EU
- Multiple user accounts per Buoy Owner
- The case of companies with vessels under several flags
- Who will submit the data: BO company ground staff, or vessel-based staff?

## **Improvements beyond launch**

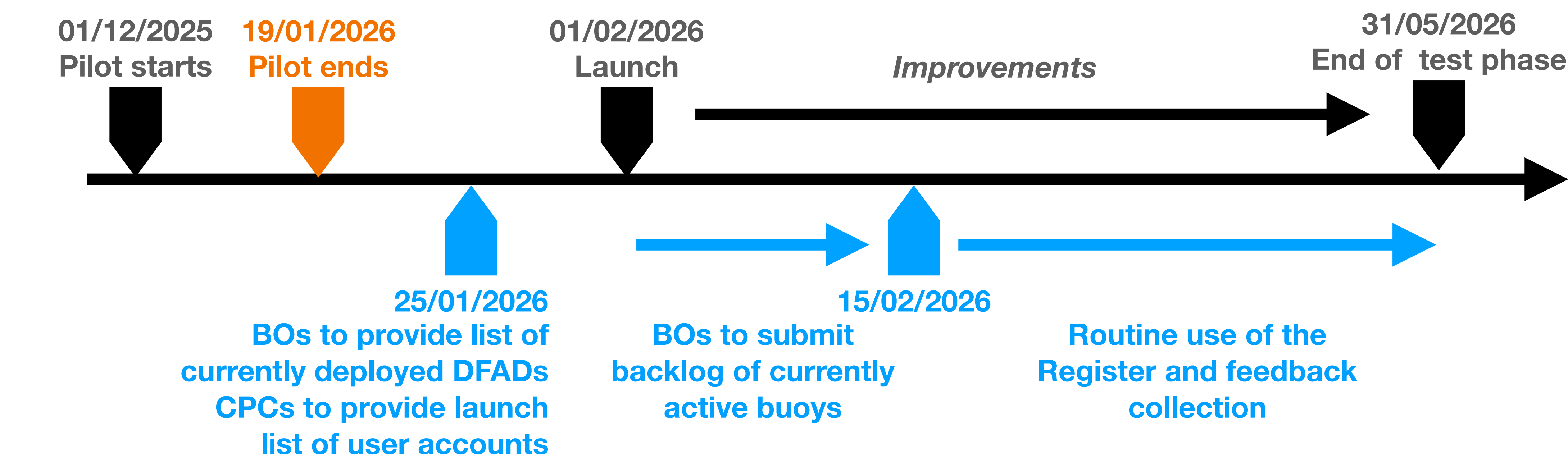
- Flag CPC correction/validation process
- Data export
- Other improvements as required/requested

# e-DFAD: capacity building

- User guides will be provided for CPCs and BOs ahead of launch (in EN and FR)
- Possible one-on-one or group training session for all CPCs after launch
- Possible one-on-one training sessions with BOs/fishing companies after launch
